***Draft 2008 Disaster Recovery Initiative (DRI) Action Plan for the State of California***

The State of California, Department of Housing and Community Development (Department), is soliciting public review and comment to the *Draft 2008 Disaster Recovery Initiative (DRI) Action Plan for the State of California*. The Action Plan has been prepared in compliance with the United States Department of Housing and Urban Development (HUD) pursuant to title IV of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C.).

The Action Plan will be submitted to HUD by December 31, 2009. Upon approval, the State of California will administer approximately \$39.5 million in federal funds for CDBG eligible activities. These funds are subject to and comply with the provisions of the HUD Disaster Recovery Initiative (DRI) 2008 Supplemental CDBG Appropriations notice [Docket No. FR-5337-N-01] (<http://edocket.access.gpo.gov/2009/pdf/E9-3216.pdf>).

The public review period for this document will be 12 calendar days, starting Thursday, December 17, 2009, through Monday, December 28, 2009. The Department must receive all comments on this document by 4 p.m., on December 28, 2009.
