DRAFT ACTION PLAN FOR HUD'S
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
DISASTER RECOVERY FUNDS**

The State of California, Department of Housing and Community Development (HCD), is soliciting public review and comment on the Draft Action Plan for 2005 CDBG disaster recovery funds.

The Action Plan is required by HUD prior to release of Disaster Relief Initiative (DRI) funds. After receiving public comment and comments from HUD, the State will follow the Action Plan for distributing the ten million dollars in DRI funds to areas impacted by disasters in 2004.

The State of California, Department of Housing and Community Development (HCD), is soliciting public review and comment on the Draft Action Plan. The public review period for this document is 30 days, which begins **May 11, 2005 through June 10, 2005**. HCD must receive all comments on these documents by **June 13, 2005**. The Draft Action Plan is available for public review in Sacramento at HCD's Housing Resource Center in Room 430, on HCD's website: www.hcd.ca.gov, at CDBG departments of entitlement cities and counties, and at the following depository libraries:
