The Department of Housing and Community Development (Department) announces the availability of approximately \$24 million in funding under the 2010 – 2011 General Allocation and \$1.5 million for the 2008 – 2011 Native American Allocation. Eligible Community Development Block Grant Program (CDBG) jurisdictions may submit an application for a maximum grant of \$800,000.

The final filing date for all applications is June 25, 2010. Applications will be evaluated and awarded on a competitive basis until all funds are expended. The award announcement is expected to be in September of 2010 by the Department.
