



**SUBJECT:** **RE-ISSUANCE OF NOTICE OF FUNDING AVAILABILITY  
CY 2010 FUNDING ROUND**

As you may know, on June 3, 2011, the Department released a memo announcing the lifting of the pause on general obligation bond funded programs and plans to make new awards for many programs, including the Housing-Related Parks Program (HRPP). A copy of this memo and the updated Notice of Funding Availability (NOFA) schedule is available on the Department's website at <http://www.hcd.ca.gov/fa/pmib.html>.

As a result, the Department is reissuing the 2010 Program Year HRPP NOFA. Approximately \$20 million will be available for the 2010 Program Year pending the enactment of the 2011-2012 State budget. Applications will be accepted now through July 29, 2011.

Applications must be submitted using the application format contained in the Application Package. Program guidelines, application instruction and forms, and related program information are available on the Department's website at <http://www.hcd.ca.gov/hpd/hrpp/>.

All applicants must submit one original hard copy application with all required attachments and one electronic copy (saved to CD-Rom) of the application forms. Applications transmitted by e-mail or by facsimile will not be accepted.

Please note, the Department will accept applications with draft resolutions. However, applicants must provide an approved resolution within 30 days of the date of submission.
