**Subject: 2010 ANNUAL GENERAL PLAN AND HOUSING ELEMENT
PROGRESS REPORT DRAFT**

The following report addresses a requirement by the State of California for each city to prepare and submit to the State an annual progress report on the status of the City's Housing Element, along with the City's progress in its implementation. Although the City of Adelanto is a charter city and exempt from this requirement, the Department of Housing and Community Development encourages all jurisdictions to submit an annual report as the report is a useful tool in meeting the review and revise requirement of subsequent housing element revisions per Government Code Section 65588. In recognition of the value of preparing an annual review on the status of the housing element and the general plan, the City of Adelanto has prepared the 2010 Annual General Plan and Housing Element Progress Report. The report reflects projects that the City adopted, commenced implementation on, or completed during the 2010 calendar year.

In order to show that the City is moving forward with this planning effort, the City of Adelanto is hereby submitting a draft of the 2010 Annual General Plan and Housing Element Progress Report prior to the April 1, 2011 deadline. The report will be presented to the City Council for its consideration during a regularly scheduled public meeting in June. Upon City Council approval, the City will then send the final report to the State Office of Planning and Research (OPR) and the Department of Housing and Community Development (HCD) by June 1, 2011.

LAND USE ELEMENT

Goal LU 1: To respect the desert environment, to the maximum extent possible, while integrating an urbanized atmosphere.

Method of Implementation: Require sustainable plumbing fixtures; Preservation/relocation of endangered plants and species; Require use of drought tolerant landscaping; Follow design criteria of the Community Design Element; Wastewater reclamation program; Provide residents with water conservation tips and education.

Status: Landscape/Water Conservation Ordinance adopted February 2006; Engineering adopted Master Plan for drainage and has been conditioning projects for drainage improvements; Staff review of projects; City is working with CA Dept of Fish and Game for protection of species

Future Action: Continue review of projects and execution of implementation strategies

Next Review: On-going

Goal LU 2: To manage growth according to the General Plan for land use, assuring that community services are adequate to meet existing and proposed community needs.

Agency/Department: Planning Department; Public Works Department

Funding Source: Development Fees

Method of Implementation: Staff Review of Projects; Require infrastructure to be in place prior to occupancy of new development, balance of short term development demands and long range goals, all developments are designed to accommodate buildout road dedications at approval.

Status: Public Works tracks and reviews Utility Feasibility Studies, Staff review of projects, continually pursue annexations.

Future Action: Continue Review of Projects as Required; Ongoing public works tracking and review of utility needs.

Next Review: On-going

Goal LU 3: To provide a balanced mix of land uses and development patterns which provide the maximum flexibility to the development community.

Related Policies: LU 3.1, LU 3.2, LU 3.3

Agency/Department: Planning Department

Funding Source: General Fund

Method of Implementation: Staff Review of Projects; Development Code Standards; Incorporation of Design Standards in Community Design Element.

Status: Implementation of development standards and project review of development proposals is on-going.
Future Action: Continue to implement development standards with emphasis on coordination of development plans.
Next Review: Annual

Goal LU 4: To promote the transformation of George Air Force Base into a major airport.

Related Policies: LU 4.1, LU 4.2
Agency/Department: Victor Valley Economic Development Authority
Funding Source: Redevelopment funds
Method of Implementation: Require development to be in conformance of airport plans, and conform to policies and regulations established in the 65 CNEL and over flight areas, and encourage airport master plan.
Status: Base is now the Southern California Logistics Airport (SCLA), and the Airport master plan has been completed.
Future Action: Continue promotion of SCLA
Next Review: Annual

Goal LU 5: To promote industrial, business, and commercial development that provides for increased jobs and strengthens the local economy.

Related Policies: LU 5.1, LU 5.2, LU 5.3, LU 5.4, LU 5.5
Agency/Department: Redevelopment Agency, Planning Department
Funding Source: General Fund, Redevelopment Funds
Method of Implementation: Continue industrial development program, allow neighborhood commercial centers at major intersections within residential districts pending a CUP, and aggregation of small parcel to minimize incongruous development.
Status: Land is appropriately zoned surrounding the SCLA. However, there have not been many new commercial projects proposed in the City to provide additional jobs.
Future Action: Continue promotion of this goal. Consider adding an Economic Development Element to the General Plan to provide greater direction to this effort. Add policies to revitalize older commercial core, and include revisions to land use map to discourage strip-commercial type development. Allow neighborhood commercial centers at major intersections within residential districts.
Next Review: Annual

Goal LU 6: To provide for a conversion of the current U.S. 395 corridor into a super arterial roadway and focus on the implementation of Freeway 395.

Related Policies: LU 6.1, LU 6.2, U 6.3
Agency/Department: Southern California Association of Governments (SCAG), SANBAG
Funding Source: Measure I funds
Method of Implementation: Require a comprehensive US 395 corridor study be prepared; Initiate cooperative dialogue with Victor Valley and Caltrans.
Status: 395 is dedicated as a super arterial roadway in Circulation element; Working with other cities, counties, SANBAG, and Caltrans; SANBAG has terminated efforts on Realignment EIR, Caltrans is continuing efforts, but has shifted focus in the interim to improving the existing corridor, and the 395 realignment has been put on an indefinite hold.
Future Action: Continue cooperation with associated agencies

Next Review: On going

Goal LU 7: Promote the inclusion of safe, attractive, well-served, and affordable housing to complement the presence of the industrial district, the airport complex, and the commercial centers in Adelanto.

Related Policies: LU 7.1, LU 7.2, LU 7.3, LU 7.4

Agency/Department: Planning Department; Redevelopment Agency

Funding Source: General Fund; Redevelopment Funds

Method of Implementation: Enforce Development Regulations; Staff review of projects; Require use of streetscape and edge treatment to buffer homes; Utilize xeriscape landscaping; Allow incorporation of residential units above or with commercial uses pending a CUP.

Status: The City promotes affordable housing and the zoning allows for such development. However, mixed use projects consisting of residential with commercial uses have not been proposed in the City.

Future Action: Continue to promote and encourage affordable housing.

Next Review: Annual

RESIDENTIAL LAND USES

Goal RE 1: To encourage a range of residential product types and price ranges.

Related Policies: RE 1.1, RE 1.2

Agency/Department: Planning Department

Funding Source: General Fund

Method of Implementation: Designate a variety of residential districts throughout the planning area; Implement programs of the Housing Element; and continue to "fast-track" low cost single family housing developments.

Status: Multifamily residential zones are located near commercial developments, however some parcels are not serviceable by City utilities; Redevelopment Agency (RDA) not active.

Future Action: Continue to promote Housing Element Programs; Certify and Adopt updated Housing Element and Programs; continue to expand infrastructure and public services.

Next Review: Annual

Goal RE 2: To establish healthy, livable neighborhoods with adequate support uses including parks, schools, and neighborhood commercial centers.

Related Policies: RE 2.1, RE 2.2, RE 2.3

Agency/Department: Planning Department; Building Department; Public Works Department; Parks Department

Funding Source: General Fund

Method of Implementation: Require inclusion of parks, schools, and commercial centers that support projected demand; Require residential development to follow design criteria of the Community Design Element; Require inclusion of pedestrian and non-vehicle circulation routes; Require development to adhere to development standards; Assure adequate infrastructure, circulation and public services.

Status: Parks Master Plan is in process; Developers pay impact fees for parks and schools; City staff reviews projects.

Future Action: Develop standards for mixed-use projects; Continue to make developers pay development impact fees; Establish guidelines that address “defensible space”; Finalize the Parks Master Plan.
Next Review: Annual

Goal RE 3: Assure adequate infrastructure, circulation, and public services adequate to serve the residential developments.

Related Policies: RE 3.1, RE 3.2
Agency/Department: Planning Department; Public Works Department; Engineering Department
Funding Source: General Fund
Method of Implementation: Require adequate provisions of infrastructure, circulation, and public services as a condition of all residential development; Identify priority areas within City and help owners/developers organize financing mechanisms for infrastructure by the use of strategies in Public Facilities Element.
Status: City collects development fees; City uses lighting and landscaping districts to maintain improvements in public ROW; Public Works reviews projects and requires adequate infrastructure, circulation, and public services.
Future Action: Continue review and conditioning of adequate infrastructure, circulation, and public services; Continue to collect development impact fees and use lighting and landscape districts to maintain public ROW.
Next Review: On-going

Goal RE 4: To maintain a positive, high quality community image within the residential districts.

Related Policies: RE 4.1, RE 4.2
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: City review of all projects; Require varied architectural design of residential development; Require conformance of the laws established in 65 CNEL noise contour and overflight areas of the airport.
Status: City staff continually reviews development projects.
Future Action: Continue staff review of development projects.
Next Review: Annual

COMMERCIAL LAND USES

Goal CLU 1: Provide adequate commercial facilities to satisfy the business and service needs at the sub-regional, community, and neighborhood levels.

Related Policies: CLU 1.1, CLU 1.2, CLU 1.3, CLU 1.4, CLU 1.5
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Permit commercial uses with a CUP at all major intersections; Designate land use patterns that will guide commercial and service activities into areas that will be convenient and mutually beneficial for the public; Promote transportation facilities that provide convenient access to commercial centers.
Status: Commercial land use patterns are mostly along major highways; City staff reviews projects to ensure compatibility with Community Design Element and consistency with the Circulation Element.
Future Action: Develop standards to allow commercial project with a CUP at the intersection of major designated arterials; continue to review projects and

ensure consistency/compatibility with the General Plan Elements;
Encourage commercial development that targets the community's needs.
Next Review: On-going

Goal CLU 2: Assure provision of infrastructure, circulation, and public services adequate to serve commercial areas.

Related Policies: CLU 2.1
Agency/Department: Planning Department; Public Works Department; Building Department; Engineering Department
Funding Source: General Fund
Method of Implementation: Establish funding mechanisms, pursuant to developer's request, to pay for provisions of infrastructure serving commercial areas
Status: City reviews projects and requires adequate infrastructure, circulation, and public services
Future Action: Continue review and conditioning of adequate infrastructure, circulation, and public services; Continue to collect development fees and use lighting and landscape district to maintain public ROW
Next Review: On-going

Goal CLU 3: Minimum commercial intrusion on residential areas.

Related Policies: CLU 3.1, CLU 3.2, CLU 3.3, CLU 3.4
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: City permits commercial uses in designated commercial areas
Status: City Staff reviews commercial projects for potential conflicts with surrounding uses as part of the development review process
Future Action: Continue review of projects to minimize impacts on residential areas.
Next Review: Annual

Goal CLU 4: Assure that compatible commercial land uses are provided within the overflight areas surrounding the Airport.

Related Policies: CLU 4.1
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Require properties within the CR and CR-2 designations to utilize noise reduction construction techniques.
Status: The CR-2 zone is still a valid zone, no changes have been made to remove the zoning designation, City requires conformance with FAA and Airport Authority regulations
Future Action: Continue to require conformance with FAA and Airport Authority regulations.
Next Review: Annual

AIRPORT DEVELOPMENT DISTRICT

Goal ADD 1: Assure that the ADD is capable of containing and supporting the development of a major airport facility that will accommodate Southern California's current and future unmet air transportation demand.

Related Policies: ADD 1.1, ADD 1.2

Agency/Department: Planning Department; Public Works Department
Funding Source: General Fund
Method of Implementation: Assist, as funds become available, with relocation of residents/businesses located in ADD which are not consistent with ADD zoning designation/code; require projects in ADD zone to be master planned.
Status: ADD District has not been developed due to lack of demand, and lack of utilities.
Future Action: Encourage growth in the ADD District, and continue expansion of public services into the area.
Next Review: Annual

Goal ADD 2: Assure the development of functional and attractive design of all structures, facilities, and landscaping located within the ADD.

Related Policies: ADD 2.1
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Require strict design review procedures; Follow policies established; Develop an ADD zone district regulations within the Zoning Code
Status: City has not had any developments proposed within the ADD district.
Future Action: Continue to promote growth in the ADD district and develop ADD zone district regulations within the Zoning Code.
Next Review: Annual

Goal ADD3: Assure that the ADD can function properly and effectively without creating severe adverse impacts on the surrounding community.

Related Policies: ADD 3.1, ADD 3.2
Agency/Department: Planning Department,
Funding Source: General Fund
Method of Implementation: Require all developments within the potential 65 CNEL noise contour to conform to construction standards according to local, state and federal guidelines.
Status: Coordinate policies within the Noise Element and within the Zoning Code.
Future Action: Continue to require all developments to conform to the established guidelines and standards relating to noise.
Next Review: On-going

AIRPORT PARK

Goal AP 1: Provide a continued use of the airfield for private aviation.

Agency/Department: Planning Department; Public Works Department; Building Department
Funding Source: General Fund
Method of Implementation: Assure that the continued use of AP designation does not interfere with the long range plan of the Adelanto Airport.
Status: The AP overlay has been prepared and adopted January 2009.
Future Action: Continue implementation of the AP Overlay Zone.
Next Review: On-going

Goal AP 2: Assure provision of infrastructure, circulation, and public services adequate to serve new uses within the AP designation.

Related Policies: AP 2.1
Agency/Department: Planning Department; Public Works Department; Engineering Department
Funding Source: General Fund
Method of Implementation: Require adequate provisions of infrastructure, circulation, and public services as a condition of all developments within the AP, Assure that surrounding land uses are buffered from AP uses.
Status: City is working on the AP Overlay Zone draft to guide development within this area.
Future Action: Continue staff review of development projects, and Finalize AP code section
Next Review: On-going

Goal AP 3: Encourage residential and business park uses within the AP zone.

Related Policies: AP 3.1
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Encourage development of new residential uses within the AP designation.
Status: City encourages residential uses within the AP zone
Future Action: Change wording of strategy AP 3.1.1 to read "allow" not "encourage".
Next Review: On-going

LIGHT MANUFACTURING AND MANUFACTURING/INDUSTRIAL

Goal MI 1: Assure that the manufacturing/industrial development in the City continues to thrive.

Related Policies: MI 1.1, MI 1.2
Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Plan for and require as condition of approval for projects, transportation facilities that promote convenient access to/from the major regional circulation network.
Status: City requires road improvements as a condition of a project.
Future Action: Continue requirement of improvements as a condition of approval for a project, and consider requiring sidewalks within industrial developments.
Next Review: On-going

Goal MI 2: Assure the provision of infrastructure, circulation, and public services adequate to serve the MI district.

Related Policies: MI 2.1
Agency/Department: Planning Department, Public Works Department, Engineering Department
Funding Source: General Fund
Method of Implementation: Project review process; requirement for the adequate provisions of infrastructure, circulation, and public services for new projects.
Status: Staff continually reviews new projects for consistency with the Public Facilities Element.
Future Action: Continue to review projects and require adequate provisions of infrastructure, circulation, and public services.
Next Review: On-going

Goal MI 3: Minimize MI intrusion on surrounding residential neighborhoods

Related Policies: MI 3.1, MI 3.2
 Agency/Department: Planning Department
 Funding Source: General Fund
 Method of Implementation: Require industrial developments to minimize the impacts on residential areas, by means such as fencing, berms, trees, open space, cul-de-sacs, landscaping, building orientation, etc.
 Status: City addresses this as part of their project review process but lacks development and performance standards within the zoning code.
 Future Action: Continue staff review of projects; Establish development and performance standards within the zoning code to address protections measures for surrounding residential neighborhoods.
 Next Review: Ongoing

Goal MI 4: Attempt to plan for the inclusion of mass transit systems linking residential areas to the Manufacturing/Industrial district.

Related Policies: MI 4.1
 Agency/Department: Planning Department; Public Works Department; Engineering Department
 Funding Source: General Fund
 Method of Implementation: As alignments are established require the retention of rights-of-way for local and regional transit system including light rail and super speed trains.
 Status: City continues to work with VVTA, and is in support of local and regional transit systems.
 Future Action: Continue to support plans for light rail or super speed trains.
 Next Review: On-going

Goal MI 5: Encourage the introduction of “clean industry” to the Manufacturing/Industrial district and Light Manufacturing district.

Related Policies:
 Agency/Department: Planning Department; Public Works Department
 Method of Implementation: Require adequate mitigation measures as conditions of approval for any “heavy” manufacturing or industrial development; Require compliance with Mojave Desert Air Quality Management District Attainment Plan.
 Status: City includes proper mitigation measures for all industrial developments in addition to requiring compliance with the MDAQMD Attainment Plan.
 Future Action: Continue implementation of mitigation measures and MDAQMD Attainment Plan.
 Next Review: On-going

OPEN SPACE/PUBLIC LAND/SCHOOL/PUBLIC FACILITIES/COMMUNITY FACILITY

Goal OPC 1: Provide a comprehensive open space system throughout the City utilizing the drainage courses that are identified in the Master Drainage Plan for Adelanto.

Related Policies: OPC 1.1, OPC 1.2, OPC 1.3
 Agency/Department: Planning Department; Public Works Department; Engineering Department
 Funding Source: General Fund
 Method of Implementation: All facilities identified on the Master Drainage Plan shall be designated as Open Space; Require use of natural channels to link recreational facilities; Require preparation of local parks standards; Use Quimby Act to acquire proper funding for such facilities.

Status: City has considered, but not implemented, locating parks next to open space/drainage channels. The channels are shown on the Land Use Map, but are not designated as Open Space.
Future Action: Revise Land Use Map to show channels as Open Space.
Next Review: Annual

Goal OPC 2: To provide the residents with quality public facilities that will keep pace with projected growth.

Related Policies: OPC 2.1, OPC 2.2
Agency/Department: Planning Department; Public Works Department
Funding Source: General Fund
Method of Implementation: Require new public and semi-public facilities in pace with new developments; Utilize development impact fees to finance public facilities
Status: City requires collection of development impact fees; Reviews new projects for identifying public facilities needs.
Future Action: Continue project reviews and collection of development impact fees; Assure that adequate public facilities are provided according to the rate of new development.
Next Review: On-going

Goal OPC 3: Encourage the development of parks and open space facilities that are of high quality design and construction to promote the health, safety, and welfare of the citizens.

Related Policies: OPC 3.1
Agency/Department: Planning Department; Public Works Department
Funding Source: General Fund
Method of Implementation: Establish landscaping and lighting maintenance districts (LLMD) to help fund amenities within the recreation system
Status: LLMD's are in place to help fund street lights and landscaping along arterial roads.
Future Action: Consider LLMD's to help to fund provision of amenities within the recreation system.
Next Review: Annual

Goal OCP 4: Encourage development of public and semi-public facilities including prisons, auto racing, motocross, etc., in the compliance with commonly accepted environmental standards.

Agency/Department: Planning Department
Funding Source: General Fund
Method of Implementation: Review projects to ensure adequate security, noise mitigations, etc. are included in project plans.
Status: City staff reviews projects for compliance with environmental standards.
Future Action: Continue to review projects; Develop clear operational standards to aide in the review projects.
Next Review: Annual

SPECIFIC PLAN AREA

Goal SPA 1: To provide for the incorporation of a future specific plan district within the Planning Area.

Method of Implementation: Encourage the development of a Specific Plan for George Air Force Base and safeguard the City against any potential environmental threats related to the base.
Status: George Air Force Base has been removed from the City's Sphere and Planning Area.
Future Action: Revise Policies and Implementation strategies to be applicable to existing conditions of the City's sphere and planning area.

CIRCULATION ELEMENT

This section includes actions that will assist City officials, staff, and the public to implement the goals and policies of the Circulation Element.

Goal 1: Improved circulation system that accommodates the projected growth of the City/community.

Status: Conditions of Approval for projects require extensions/improvements of adjacent roads.
Future Action: Continue to require extensions/improvements of roads as a condition of approval.
Next Review: On-going

Goal 2: Enhanced quality of the visual corridor through Adelanto.

Related Policies: 2, 3
Agency/Department: Planning Department; Public Works Department; Engineering Department
Funding Source: General Fund; State Gas Tax; CIP funds; Grants; Development Fees
Method of Implementation: Conditions of approval requiring landscaping and formation of landscaping and lighting maintenance districts.
Status: The City requires landscaping and enhancements of improvements as a condition of approval.
Future Action: Continue to require landscaping and enhancements as a condition of approval for all projects.
Next Review: On-going

Goal 3: Adequate capacity of roadways to handle build-out of the entire City.

Related Policies: 1, 4, 5, 6, 7
Agency/Department: Planning Department; Public Works Department; Engineering Department
Funding Source: General Fund; CIP funds; State Gas Tax; Grants; Development Fees
Method of Implementation: Conditions of approval require extensions/improvements of adjacent roads.
Status: City requires extensions/improvements of roads as a condition of approval for all projects. In addition, the City is actively working with Caltrans, SANBAG and other jurisdictions for improvements of major corridors.
Future Action: Continue interagency coordination for improvement of major corridors and continue requirement for improvement of adjacent roads for all projects.
Next Review: On-going

Goal 4: Safe, durable, and aesthetic roadway construction design that will provide a long-lasting surface for vehicular transportation.

Related Policies: 1, 2, 3, 6, 7
Agency/Department: Planning Department; Public Works Department; Engineering Department
Funding Source: General Fund; CIP funds; Grants; State Gas Tax; Development Fees
Method of Implementation: Condition of Approval and interagency coordination.

Status: City is actively working with Caltrans, SANBAG and other jurisdictions for improvements and options of high speed rail, local/subregional transit system, and relocation of highway 395.

Future Action: Continue working with relative agencies, and continue to require roadway improvements as a condition of approval.

Next Review: On-going

Goal 5: Improved access/visibility to Adelanto's primary commercial, business, and industrial sectors, including a new major airport.

Related Policies: 4, 5

Agency/Department: Planning Department; Public Works Department; Economic Development Department

Funding Source: General Fund; CIP funds; Grants; State Gas Tax

Method of Implementation: Road improvements and interagency coordination.

Status: City extended Rancho Road west to Industrial Parks 2 & 3 to facilitate access and visibility of industrial businesses. The City also joined the Victor Valley Economic Development Authority (VVEDA) for the Southern California Logistics Airport (SCLA).

Future Action: Continue improving access and visibility of commercial, business, and industrial sectors; Continue interagency discussions regarding option of local/subregional transit system and relocation of highway 395.

Next Review: On-going

Goal 6: Integrated street and signage design criteria.

Related Policies: 2

Agency/Department: Planning Department; Public Works Department

Funding Source: General Funds

Method of Implementation: Staff coordination.

Status: Standards have not been developed.

Future Action: Develop and implement standards.

Goal 7: Improved east/west and north/south circulation through Adelanto.

Related Policies: 1, 3
