Narratives

Disaster Damage:

October 2017 Wildfires (DR-4344) - The October 2017 fires spanned from the north coast of the San Francisco Bay Area, to the northern Central Valley and Orange County. Fires included the Central Lake-Napa Unit (LNU) Complex (including the Pocket, Tubbs, Nuns, and Atlas fires) in Sonoma and Napa Counties, the Mendocino Lake Complex (including the Redwood Valley and Sulphur fires), and Wind Complex (Cascade and Laporte, Lobo, and McCourtney fires)in the Tri-County region including Butte, Nevada and Yuba Counties, as well as the Canyon fire in Orange County. The October 2017 wildfires burned over 200,000 acres combined and destroyed 8,922 structures, with the Central LNU Complex fire responsible for much of the damage. The areas affected sustained approximately \$8.6 billion in property damages and losses, as reported through insurance claims. During and after the disaster, cities and counties responded with services and shelters for those displaced to help begin the process of recovery. However, one year later a survey of households with insurance claims showed 53 percent had not completed the dwelling portion of their claim and 62 percent still planned to rebuild.

December Wildfires, Mudflows, and Debris Flows (DR-4353) - The December 2017 fires, mudflows, and debris flows impacted counties across Southern California. Fires include the Thomas Fire, impacting Ventura and Santa Barbara Counties, the Rye Fire and Creek Fire in Los Angeles County, and Lilac fire in San Diego. Following the fires, debris and mudflows severelyimpacted the footprint of the Thomas Fire, devastating the Montecito area in Santa Barbara County. Across all the

Across all the Southern California fires, a total of 308,383 acres were burned, with the Thomas Fire alone becoming the largest single fire in California history at 281,893 acres burned, until the Mendocino Fire Complex in 2018. The devastation created by the fires was exacerbated by heavy rains that followed, resulting in massive mud and debris flows. Electricity, gas, cellular telephone, internet, drainage, sewer and water service were all compromised, homes were destroyed, lives were lost, and communities were displaced.

Ongoing Threat - The State of California is experiencing a heightened risk of fire danger due to drought, tree mortality, and an increase of severe weather events. Starting in 2013, Governor Edmund G. Brown Jr. declared a State of Emergency to take precautions against severe drought conditions across the state. Drought severely impacted the heath of California's forests. In December 2017, the U.S. Forest Service and the California Department of Forestry and Fire Protection (CAL FIRE) announced that a total of 129 million trees died due to drought and bark beetles across 8,900,000 acres of the state. The ongoing drought conditions inhibited tree recovery, making forests vulnerable to bark beetles and increasing the wildfire risk for California communities. Although Governor Brown lifted the Drought State of Emergency in April 2017 following the substantial winter storms in 2017, the number of dead trees remains an ongoing threat.

Recovery Needs:

In Fall of 2018, using HUD's unmet recovery needs methodology as outlined in the August 14, 2018 Federal Register Notice, the total unmet recovery needs were determined to be over \$922 million. Given the data challenges presented in the housing unmet needs analysis, however, including the limited Federal Emergency Management Agency (FEMA) Individual Assistance (IA) and Small Business Administration (SBA) home loan registrations, HCD proposed an alternative methodology for a more holistic portrait of unmet recovery needs. The Housing category includes the alternative methodology of using the boots-on-the-ground damage assessment conducted by CAL FIRE across the disaster impacted communities, which HCD believes shows a more accurate portrait of total housing impacts from the disasters. Using the alterative methodology, the State of California faces over \$2.5 billion in unmet recovery needs related to DR-4344 and DR-4353. In March 2020, HCD updated the infrastructure unmet recovery needs. While the amount of unmet recovery needs decreased for FEMA HMGP projects by approximately \$400 million, the unmet recovery needs for FEMA PA projects and other local infrastructure projects increased by more than \$90 million.

Infrastructure:

HCD and the City of Clearlake entered into an Agreement on 9/1/21 and on 9/21/21 HCD issued the City of Clearlake a Notice to Proceed for its Sulphur Fire Road Rehabilitation Project. HCD continued routing Agreements with the City of Santa Rosa signing and returning its Agreement to HCD on 8/23/21. The Agreement for the County of Sonoma continued routing, while the County of Santa Barbara continued to work to receive an Authorized Resolution to begin the Agreement process.

In July, HCD held an application preparation webinar for the 2017 DR-Infrastructure and 2017 MIT-RIP Programs and opened the application portal to enable eligible applicants to prepare applications while the Agreements are being routed. HCD also held Office Hours with eligible applicants to provide technical assistance regarding the preparation of outstanding policies and procedures that are Special Conditions in the respective Agreements and must be cleared prior to the issuing of any Notice to Proceed. HCD also used those Office Hours to provide support for eligible applicants preparing applications.

In July, August, and September HCD and the City of Clearlake met weekly for HCD to provide Technical Assistance (TA). HCD also provided feedback on the project application.

During this quarter, City and County staff met with HCD staff for monthly 1:1 technical assistance calls. Additionally, the City and HCD had multiple discussions to sort through some concerns/questions HCD had on the Heritage House/Valle Verde Project NEPA. The City began inputting the project application in Grants Network.

County staff drafted their project solicitation, submitted to HCD for review, incorporated HCD's feedback, drafted evaluation criteria and finalized their vendor list. County staff published the solicitation on September 1, 2021 and responded to vendor inquiries. County staff also continued drafting relocation procedures to clear their last master standard agreement special condition.

County provided initial responses to feedback from HCD on the Project Application and relocation plan for the Peoples' Place Project. Additionally, the County followed up with project sponsors from the remaining two projects (Westview Village II and Central Terrace) to request information needed for those Project Applications. Also, the County initiated the NEPA review process with all three projects sponsors. The County submitted the Environmental Assessment previously prepared for Westview Village II for County HOME funds to HCD's consultant for review.

HCD executed the Notice to Proceed for the Linda Tunis Senior Apartments project. City staff worked with the Linda Tunis project developer to collect documentation, work on underwriting, participate in closing meetings, and send/respond to questions about the project. Additionally, HCD issued conditional commitments for 3575 Mendocino Avenue, Phase 1 project and Caritas Homes, Phase 1 project. City staff submitted the Burbank Ave Project Application to HCD, and the Cannery at Railroad Square Project Application to HCD in September of 2021.

The OOR Program is continuing with survey intake, the Program received 992 total survey responses, 490 of which are LMI and 922 are located in MID area. The Program continues to invite survey respondents in priority tiers to complete applications, the Program is currently working with 275 applications in stages from initial entry to submitted and in processing. The Program continued to build a strong case management presence and currently has 11 case managers across the disaster area to assist disaster survivors with surveys and applications.

The Program continues local outreach within the disaster areas, also continues to work with local governments and community organizations by sending out informational materials and participating in events where the program team offers program overview presentations.

The OOR Program is continuing with survey intake, the Program received 992 total survey responses, 490 of which are LMI and 922 are located in MID area. The Program continues to invite survey respondents in priority tiers to complete applications, the Program is currently working with 275 applications in stages from initial entry to submitted and in processing.

The Program continued to build a strong case management presence and currently has 11 case managers across the disaster area to assist disaster survivors with surveys and applications. Case managers are actively processing program applications working directly with applicants, additionally, they continue reviewing submitted surveys and inviting additional respondents to apply based on prioritization tier.

The Program continues local outreach within the disaster areas, also continues to work with local governments and community organizations by sending out informational materials and participating in events where the program team offers program overview presentations.

Activity Description:

The primary objective of the Owner Occupied Housing Rehabilitation and Reconstruction Program is the provision of decent, safe, and sanitary housing in the areas impacted by the October and December 2017 disasters. The program aims to not only address disaster-related damages but also to mitigate potential future damage.

Location Description:

Activity Progress Narrative:

The Program's Construction Management Services vendor conducted the first round of initial site visits; the Programs construction manager will be conducting site visits to complete damage assessments and environmental review of individual sites.

The OOR Program is continuing with survey intake, the Program received 992 total survey responses, 490 of which are LMI and 922 are located in MID area. The Program continues to invite survey respondents in priority tiers to complete applications, the Program is currently working with 275 applications in stages from initial entry to submitted and in processing.

The Program continued to build a strong case management presence and currently has 11 case managers across the disaster area to assist disaster survivors with surveys and applications. Case managers are actively processing program applications working directly with applicants, additionally, they continue reviewing submitted surveys and inviting additional respondents to apply based on prioritization tier.

The Program continues local outreach within the disaster areas, also continues to work with local governments and community organizations by sending out informational materials and participating in events where the program team offers program overview presentations.
