The Department approves the State of California's Action Plan Amendment (APA) #1 for Community Development Block Grant Disaster Recovery (CDBG-DR) funds appropriated under Public Laws 115-123 and 116-20 under grant number B-18-DP-06-0001. On August 14, 2018, under Public Law 115-123, HUD allocated \$124,155,000 to the State for long-term recovery and unmet needs from the 2017 wildfires, mudflow and debris flow. On January 27, 2020, under Public Law 116-20, HUD allocated an additional \$38,057,527 to address California's unmet infrastructure recovery needs related to those disasters. This Amendment adjusts program budgets to account for the additional allocation.

APA #1 will create a new program, remove a program and update existing programs. Descriptions of the primary modifications to the State's Action Plan is listed below:

- Add Infrastructure Program. Department of Housing and Community Development (DHCD) new infrastructure program will address the ongoing unmet infrastructure needs of local communities.
- Remove FEMA Public Assistance Match Program. The Federal Emergency Manage Agency (FEMA) Public Assistance (PA) Match program will be discontinued and PA Match activities will be funded through the new infrastructure program.
- **Expand Multifamily Housing Program.** DHCD will move funding from the initial FEMA PA Match program (\$3,531,803) to expand assistance to help address the unmet recovery needs of low- and moderate- income renter households.
