Housing Element and APR Background

Housing Elements

Submitted by local jurisdictions to HCD on 5 or 8-year cycles

Housing Element Annual Progress Reports (APRs)

Local jurisdictions provide annual updates on Housing Element implementation

Data from APRs

2017: Limited data on building permits
2018 and beyond: Expansive data on the entire development pipeline
(from initial application to certificates of occupancy)
2021: APR Dashboard created to help visualize expanded data



APR Dashboard Overview

The new APR dashboard will:

- Show housing activity around the state
- Map APR data in a variety of ways
- Share summaries, trends, and more detailed data
- Compare regions and jurisdictions
- Analyze affordability and RHNA progress
- Publicize the status of Housing Element and APR compliance
- Provide more accessible information than prior data sharing efforts



Stakeholder Feedback

Feedback sessions were held with the following groups during the dashboard development process:

Academics	UC Berkeley Terner Center for Housing Innovation, UC Berkeley Urban Displacement Project, UC Berkeley Law, UC Davis Law, UC Irvine Urban Planning

Feedback was overall very positive and encouraged HCD to modify the dashboard to make the information more accessible:

- Added background information and explainers
- Built in slicers and other ways to filter data



- Data self-reported by local jurisdictions
- Difficulty tracking projects through their life cycle
- Limited data pre-2018
- Some projects cannot be geocoded
