
Overview of Braiding Funds & Guidelines





Overview: What is braiding funds?

Weaving together of federal, state and private funding streams to support high quality programs



Braiding Funds

Braiding Funds vs. Supplanting Funds

"supplement don't supplant!"

Braiding	Supplanting
Funding sources are coordinated to support the cost of a program	Federal funding replaces state or federal funding
Funding increases the level of services	State or local government reduces government funding for a program because federal funds are available
Funding can be tracked back to the original source and therefore maintains any requirements of those funds	Paying for services, staff, programs, or materials that would otherwise be paid with state/local funds



Braiding Funds: Guidelines

ESG-CV Supplanting Rules ("Maintenance of Effort"):

- Rule does not apply to Rapid Re-Housing funds
- Only applies to essential services related to street outreach and emergency shelter
- See <u>24 CFR 576.101(c)</u> and <u>576.102(d)</u>





Question: We have 2 shelter programs that were funded by onetime state funds which will be fully expended by June 30, 2020. We would like to use some of our ESG-CV to continue these programs and maintain our crisis bed capacity. Do Maintenance of Effort regulations apply to one-time funds that are ending? ESG would not be supplanting any ongoing funding source.

Answer: Unless expressly stated otherwise by a HUD waiver, the maintenance of effort requirements continue to apply for purposes of annual ESG funding and ESG-CV funding, and ESG-CV funding must not be used to replace or reduce the amount of non-Federal funding local governments must maintain and use for street outreach and emergency shelter essential services.



Braiding Funds – Guidelines

ESG-CV funds may be braided with other state/federal funds if the following applies:

- No other public funding source is being provided for the same type of assistance at that time; AND
- The program participant must meet the eligibility criteria for ESG assistance; AND
- The funding is necessary to help the program participant regain stability in their current Permanent Housing (PH) or move into other PH and achieve stability in that housing
- See <u>24 CFR § 576.105(d)</u> and <u>24 CFR § 576.106(c)</u>)



Braiding Funds – Guidelines

Restrictions:

- Only applies to ESG-CV funded rental and financial assistance
- Does NOT apply to services such as housing search and placement and housing stability case management







Question: The County wants to support a vaccination clinic site that will be operated by the local Public Health Department. Can the County support this clinic site and what are the ESG and ESG-CV eligible costs?

Answer: ESG-CV funding may NOT be used to replace or reduce funds that the public health department typically provides for vaccination clinics. The County would need to talk with its public health partner to determine what costs are covered and what needs to be covered.

Funding Amounts and Time Constraints:	 The State budget includes an additional \$2.75 billion in funding for the Homekey program to be administered by HCD over 2 years, using a mix of American Rescue Plan funding (\$2.25 billion) and General Funds (\$500 million) to support the acquisition and conversion of properties into affordable and supportive housing or interim housing. 				
Eligible Activities:	 Awarded funds can be used to provide permanent or interim housing for individuals and families experiencing homelessness or at risk of experiencing homelessness. See https://homekey.hcd.ca.gov/content/eligibility got more information on eligible uses. 				
Status of State Actions to Date:	 The State announced the release of \$1.45 billion in Homekey grant funds on September 9, 2021 and the Notice of Funding Availability is at https://homekey.hcd.ca.gov/. The application will be available September 30, 2021 and due by Monday, May 2, 2022 at 11:59 p.m. PST, or until the available funds are exhausted, whichever occurs first. All applicants will be required to engage in a Pre-application Consultation prior to applying. Another round of funding for Homekey will be announced in 2022, bringing the total to \$2.75 billion. 				
Strategic Guidance for Local Use of Funds:	 Recommended Use: These funds should be used to acquire hotels/motels and other buildings and facilities to be used for permanent housing, for housing that can be used as interim housing with eventual ability to convert to permanent housing, or for interim housing with a focus on supporting people to exit to permanent housing. A priority should be placed on using funding to create permanent supportive housing units, if feasible. 	HOMEKEY

Strategy Development Steps

Use your local data to consider where there is need:

- Unsheltered
- Sheltered and needing permanent housing
- Access to resources
- Ways to accelerate monthly housing placements
- Identify which interventions are needed (new and existing)
- Pay attention to funding expenditure deadlines to prioritize order of spending money

Micro- and Macro- Braiding





Micro- and Macro- Braiding Funds

- Micro-braiding: individual service provider working with an eligible program participant and utilizing multiple funding sources to support housing stability
- Macro-braiding: organization- or community-level planning and implementation efforts using multiple funding sources to support multiple activities



Micro-braiding Example

Individual presents with 4 months of rental arrears and in need of ongoing rental assistance

- Rent relief funds can pay for rental arrears and 3 months of prospective rental assistance
- ESG-CV funds can pay for rental arrears
- HHAP funds can pay for rental assistance
- Braiding: use Rent Relief funds to pay for rental arrears, 3 months of prospective rental assistance, HHAP for future rental assistance
- Can the case manager also use ESG-CV to pay for prospective rent?



Micro-braiding Example

- Program participant and his 5-year-old daughter are living unsheltered, and a 2-bedroom apartment just became available in a rapid rehousing program
 - ESG-CV funds can pay for rental assistance, furnishings, and case management
 - Private funding can pay for furnishings, childcare, public transportation costs
 - Braiding: use ESG-CV to pay for rental assistance and case management, use private funding to pay for furnishings, childcare, and public transportation costs so client can get to/from job



Macro-braiding Example

Community has 0.5% vacancy rate, PIT count has shown an increase in unsheltered homelessness, more units are needed to address those living unsheltered

- Homekey can pay for NCS and PSH
- CDBG can pay for rehabilitation (public services)
- HOME ARP can pay for affordable housing development
- ESG-CV, HHAP can pay for rental assistance
- Braiding: Use Homekey to pay for NCS acquisition, CDBG for NCS rehabilitation, HOME ARP for PSH development, HHAP for rental assistance, ESG-CV for supportive services

Macro-braiding Example – Eligible Funding

- City has 1.5% vacancy, CoC set up NCS at the beginning of pandemic through Project Roomkey, focus is now on rehousing
 - HHAP (rental assistance, supportive services, flexible housing subsidy)
 - Homekey (housing units)
 - ESG-CV (rapid rehousing, landlord incentives, sponsor-based rental assistance, essential services)
 - EHV (rental assistance, housing placement costs)
 - CalWORKs (rental assistance)
 - Continuum of Care (rapid rehousing)
 - HMIS (data set up, collection, use and reporting)

VICF Macro-braiding Example – Funding Priorities

- City has 1.5% vacancy, CoC set up NCS at the beginning of pandemic through Project Roomkey, focus is now on rehousing
 - ESG-CV for rapid rehousing, landlord costs, and HMIS costs
 HHAP, CoC, CalWORKs for rapid rehousing
 - EHV for permanent housing
 - Homekey (available housing units)
