NOTE: Based upon the total number of applications scored and ranked, and the total funds available, the Department established the following point score cut-off: for Rural projects, a minimum score of 110 points; for Senior projects, a minimum score of 116 with a maximum tiebreaker of 0.3904762; for projects located in the North, a minimum score of 116 with a maximum tiebreaker score of .3356322; for projects located in the South, a minimum score of 116 with a maximum tiebreaker score of .2946154, would be necessary for an application to fall within the competitive point score range.
