Veterans Housing & Homelessness Prevention (VHHP) Program 2018 Round 4 Awards Data Summary

Based on cumulative awards to date, the VHHP Program estimates that 55% of housing units expected are reserved for veteran households. Based on Round 4 awards, VHHP funds account for 16% of total development costs.
