For all income categories, the income limits for households larger than eight persons are determined as follows: For each person in excess of eight, add eight percent of the <u>four-person</u> "50%" limit to the "50%" limit for <u>eight persons</u> and round the answer to the nearest \$50. For example, the nine-person "50%" limit for Yuba County equals \$41,260 (\$29,450 * 0.08 = \$2,356, added to \$38,900 = \$41,256, rounded to \$41,260).
