Guidelines for Registration of a Manufactured Home/Mobilehome on Yearly Registration Renewal Fee and Tax Waiver Program

Effective January 1, 2017, through December 31, 2020, owners of manufactured homes and mobilehomes who are currently not the registered owner(s) in the Department of Housing and Community Development (HCD) records are eligible to apply to register their homes with the Department and obtain waivers from certain fees and back taxes.

These guidelines are specifically for unregistered homes that have an HCD decal number that begins with the letter "A" and are subject to in lieu taxation (ILT).

In order to apply for the fee and tax waiver and to register the home, the person asserting an ownership interest (the applicant) shall file an application to register as the new owner, pay any required fees, and submit the following:

- Documentation demonstrating chain of ownership, which includes the following:
 - An **authentic** HCD Certificate of Title (not a copy) signed by all owners (Registered Owner or Legal Owner) printed on the title. The applicant shall complete the "New Owner Information" section and sign where appropriate.
 - If the original last-issued HCD Certificate of Title is unavailable, an [Application for Duplicate Certificate of Title Form \(HCD RT 480.4\)](#) can be completed, with releasing signatures from all owners (Registered Owner or Legal Owner) on record with HCD. The applicant shall complete the "New Owner Information" section and sign where appropriate.
 - Use of the bond process: if the applicant is unable to obtain the release from the registered owner(s), legal owner(s) or junior lienholder(s), which is not a financial institution, the applicant must comply with the information and instructions in form [Bond or Undertaking Requirements for Manufactured Homes/Mobilehomes, Commercial Modulares, Truck Campers, and Floating Homes \(HCD RT 480.0\)](#) and submit the required form [Statement of Facts - Bond \(HCD RT 476.6I\)](#).
- The **authentic** registered owner's Registration Card (not a copy) or, if unavailable, an [Application for Duplicate Registration Card Form \(HCD RT 481.2\)](#) completed.
- [Multi-Purpose Transfer Form \(HCD RT 476.6G\)](#) with appropriate sections completed and signed by the applicant(s).
- [Certification of Retail Value and Purchase Price \(HCD RT 476.4\)](#) completed by the applicant. Page 2 of this form may be submitted to HCD to obtain the retail value. Use Tax will be paid on the lesser of the retail value of the home or purchase price.
- Required Fees:
 - \$50 Fee and Tax Waiver Processing Fee – includes transfer fee, duplicate title, duplicate registration card and informal title search.
 - \$10 Mobilehome Recovery Fund Fee – due with a transfer of title for a sale of a manufactured home.
 - *Variable – Use Tax calculated using Form HCD RT 476.4 based off the retail value or purchase price of the sale.
 - *Variable – Use Tax Penalty calculated by taking 10 percent from the original Use Tax amount.

Guidelines for Registration or Conditional Registration of a Manufactured Home/Mobilehome on Local Property Tax Fee and Tax Waiver Program

Effective January 1, 2017, through December 31, 2020, owners of manufactured homes and mobilehomes who are currently not the registered owner(s) in the Department of Housing and Community Development (HCD) records are eligible to apply to register or conditionally register their homes with HCD and obtain waivers from certain fees and back taxes.

These instructions are specifically for homes that have an HCD decal number that begin with the letter "L" and are subject to local property tax (LPT).

In order to apply for the fee and tax waiver and to register the home, the person asserting an ownership interest (the applicant) shall file an application to register as the new owner, pay any required fees, and submit the following:

- Documentation demonstrating chain of ownership, which includes the following:
 - The **original** last-issued HCD Certificate of Title (not a copy) signed by all owners (Registered Owner or Legal Owner) printed on the title. The applicant shall complete the "New Owner Information" section and sign where appropriate.
 - If the original last-issued HCD Certificate of Title is unavailable, an [Application for Duplicate Certificate of Title \(HCD RT 480.4\)](#) can be completed, with releasing signatures from all owners (Registered Owner or Legal Owner) on record with HCD. The applicant shall complete the "New Owner Information" section and sign where appropriate.
 - Use of the bond process: if the applicant is unable to obtain the release from the registered owner(s), legal owner(s) or junior lienholder(s), which is not a financial institution, the applicant must comply with the information and instructions in form [Bond or Undertaking Requirements for Manufactured Homes/Mobilehomes, Commercial Modulares, Truck Campers, and Floating Homes \(HCD RT 480.0\)](#) and submit the required form [Statement of Facts - Bond \(HCD RT 476.6I\)](#).
- The **original** last-issued registered owner's Registration Card (not a copy) or, if unavailable, an [Application for Duplicate Registration Card \(HCD RT 481.2\)](#) completed.
- [Multi-Purpose Transfer Form \(HCD RT 476.6G\)](#) with appropriate sections completed and signed by the applicant(s).
- Required Fees:
 - \$50 Fee and Tax Waiver Processing Fee – includes transfer fee, duplicate title, duplicate registration card and informal title search.
 - \$10 Mobilehome Recovery Fund Fee – due with a transfer of title for a sale of a manufactured home.
 - \$23 per section Registration Fee – due with a transfer of title.
 - \$5 per section Park Rehabilitation and Purchase Fund Fee – due with a transfer of title if the manufactured home or mobilehome is located on land the applicant does not own.

Upon submission and HCD approval of the above required documents which demonstrate a right to ownership, and payment of the fees required for each step above, HCD will do one of the following:

- 1) If the applicant presents a Tax Clearance Certificate from the County Tax Collector for the county where the home is located, HCD will record their name(s) in Department records as the registered owner(s) and issue a new Certificate of Title and Registration Card to the applicant(s).
- 2) If the applicant(s) does not have a Tax Clearance Certificate, HCD will issue a Conditional Certificate of Title. The applicant must present the Conditional Certificate of Title to the County Tax Collector whom will issue either a Tax Clearance Certificate or a Tax Liability Certificate after any taxes not waived are paid. The applicant shall submit the Tax Clearance Certificate or Tax Liability Certificate, and the Conditional Certificate of Title to HCD. HCD will record their names in Department records as the registered owner(s) and issue a new Certificate of Title and Registration Card to the applicant(s).
