State of California Draft 2018-19 Consolidated Annual Performance & Evaluation Report

Draft Substantial Amendments to the State of California's 2015-2020 Consolidated Plan, 2017-18 Annual Action Plan, and 2018-19 Annual Action Plan

The State of California Department of Housing and Community Development (HCD) is soliciting public review and comment on the 2018-19 Draft Consolidated Annual Performance and Evaluation Report (CAPER), the Draft Substantial Amendment to the 2015-2020 Consolidated Plan (ConPlan); and Draft Substantial Amendments to the 2017-18 and 2018-19 Annual Action Plans (AP). The 2017-18 and 2018-19 APs are the third and fourth annual updates to the State of California's 2015-2020 ConPlan.

CAPER

The required 15-day public review period will begin on September 11, 2019, and HCD must receive all comments no later than 5:00 p.m. on September 25, 2019.

The CAPER is being prepared for submittal to the Department of Housing and Urban Development (HUD) and reports on specified federal housing and economic assistance allocated by the state for the period July 1, 2018 through June 30, 2019. The CAPER does not address funds distributed directly to local governments (entitlement jurisdictions) by the federal government.

The required 30-day public review period will begin on September 11, 2019, and HCD must receive all comments no later than 5:00 p.m. on October 11, 2019.

The draft substantial amendment to the 2015-2020 ConPlan includes updates to the current ConPlan with an attached detailed addendum. The substantial amendment is the result of the Department's comprehensive Community Development Block Grant (CDBG) Program's redesign process, in partnership with stakeholders. The draft substantial amendment includes changes to

the CDBG Method of Distribution to improve the CDBG program's low expenditure rate. The attached addendum includes a detailed summary of the new CDBG Method of Distribution. The draft substantial amendment to the 2017-18 AP is the result of additional CDBG funds being awarded than what was originally anticipated.

The draft substantial amendment to the 2018-19 AP includes required local jurisdictions' CDBG Program Income (PI) information pursuant to 24 CFR 91.320(k)(1)(iv).

The 2018-19 Draft CAPER and Draft Substantial Amendments to the 2015-2020 ConPlan, 2017-18 AP, and 2018-19 AP will be available for public review on HCD's website (http://www.hcd.ca.gov/policy-research/plans-reports/index.shtml) as of September 11, 2019, and in Sacramento at HCD's Housing Resource Center in Room 501; at planning departments of counties with at least one non-entitlement jurisdiction, and the following libraries:
