2018 CDBG-Disaster Recovery Infrastructure Program Notice of Intent Allocations Summary

2018 CDBG-DR Infrastructure Program

In recognition of the unmet recovery needs from the 2018 wildfires in California, an allocation of \$1,017,399,000 in Community Development Block Grant-Disaster Recovery (CDBG-DR) funds was granted to the State of California on January 27, 2020, through Federal Register (FR) Vol. 85 Docket 4681 under Public Laws 115–254 and 116–20, which cover Federal Emergency Management Agency (FEMA) Major Disaster Declarations DR-4382 and DR-4407. These funds are administered by the U.S. Department of Housing and Urban Development (HUD) and are intended primarily to assist housing recovery and to benefit low- and moderate-income (LMI) households impacted by the fires.

NOIs Received and Reviewed

HCD solicited Notice of Intent (NOI) submissions from eligible 2018 disaster affected communities in July of 2021 and then again in March 2022 to determine the amount of Unmet Need in those communities. These communities could submit eligible disaster related infrastructure projects that met LMI or Urgent Needs national objectives. HCD then used these Unmet Needs to calculate the proportion (see Table 1) of DR-Infrastructure funds that an eligible jurisdiction could receive.

HCD received 121 NOI submissions from 8 Eligible Applicants, totaling \$1,321,839,592 in Unmet Need; this exceeds HCD's DR-Infrastructure program funds by \$1,004,411,104.

DR-Infrastructure Allocations

Based on the Unmet Need, the DR-Infrastructure program has allocated \$317,428,488 to seven Eligible Applicants as detailed in the two tables below:
