

**Multifamily Housing Programs
2024 MTSP HERA Special Income Limits - Effective April 1, 2024**

The Housing and Economic Recovery Act of 2008 (HERA) directed HUD beginning in 2009 to publish separate income limits specifically calculated for Multifamily Tax Subsidy Projects (MTSPs). These 2024 MTSP HERA Special Income Limits apply to MTSPs located within Marin, Nevada, San Francisco, San Mateo, or Santa Clara county and placed in service (PIS) prior to 1/1/09. A different set of Income Limits (2024 MTSP Regular Income Limits) are applicable to MTSPs located in within Marin, Nevada, San Francisco, San Mateo, or Santa Clara county (HERA Special counties) and PIS on or after 1/1/09, and MTSPs located within all other counties.
VHHP restricts some units to Extremely Low Income households. Use 30% AMI income limits for these units.

These 2024 MTSP HERA Special Rent Limits apply to MTSPs located within Marin, Nevada, San Francisco, San Mateo, or Santa Clara county and placed in service (PIS) prior to 1/1/09. A different set of Rent Limits (2024 MTSP Regular Rent Limits) are applicable to MTSPs located in these five counties (HERA Special counties) and PIS on or after 1/1/09, and MTSPs located within all other counties.

VHHP restricts some units to Extremely Low Income households. Use 30% AMI rent limits for these units.
