Awarded Entity:	City of Richmond – Rydin Rd and Castro St
ERF Program Funds Awarded:	\$4,881,272.00
Funded Activities:	The City of Richmond will provide interim and permanent housing support for 102 individuals residing in a vehicle encampment in collaboration with CORE. CORE program will be providing mental health services and ERF will provide security and services on site, housing navigation, and a flexible "Housing Trust Fund" to support clients in interim and permanent housing.

Awarded Entity:	City of Fresno — Downtown Fresno Encampment
ERF Program Funds Awarded:	\$5,070,057.68
Funded Activities:	The City of Fresno will support 100 individuals across three encampments with pallet shelters, shared permanent housing, and street outreach. The plan includes mental health referrals and builds upon prior partnerships with Caltrans to support infrastructure repairs near highways and canals.

County:	Marin
Awarded Entity:	Marin County — Lee Gerner Park
ERF Program Funds Awarded:	\$317,236.00
Funded Activities:	Marin County will transition 18 individuals from a greenway encampment into stable housing, combining immediate hotel placements with intensive housing navigation and case management.

Awarded Entity:	City of Berkeley – People's Park
ERF Program Funds Awarded:	\$4,708,015.00

Funded Activities:	The City of Berkeley along with Alameda County, UC
	Berkeley, and First Presbyterian Church will provide

	shelter and a drop-in center. The plan focuses on a single

The project will provide 6-month hotel vouchers, case management, and connection to CalAIM and Project Homekey. Additionally, the city will work to restore an adjacent park site.

They will leverage rental assistance in partnership with the CoC, providing time-limited subsidies.

experience. Key strategies include rapid rehousing,
housing vouchers, and family reunification support with a
focus on Spanish speaking and immigrant services.

Funded Activities:	The City of Vista will connect 35 individuals living in encampments along a creek channel to permanent housing through rental assistance and targeted partnerships. The \$1.8 million proposal emphasizes housing navigation while addressing health barriers through coordinated care.

ERF Program Funds Awarded:	\$1,843,500
Funded Activities:	Redwood City will serve 70 encampment residents at the intersection of a highway and a major boulevard through outreach to provide housing navigation and rapid rehousing. The city will leverage existing partnerships with county behavioral health and is pursuing additional partnership towards a Homekey site.

Funded Activities:	The County of Santa Cruz will provide housing and comprehensive support services to 65 individuals living in a large riverwalk encampment through a "housing

scholarship fund" designed to secure and provide stable
housing for 2 years.

Funded Activities:	Orange County proposes to serve 60 individuals living in densely vegetated park encampments through outreach with embedded behavioral health staff, motel vouchers, and rapid rehousing. The project will also address ecological restoration at the park.

ERF Program Funds Awarded:	\$522,619.00
Funded Activities:	The City of San Rafael will serve 34 individuals living in an encampment under a highway overpass, providing permanent housing navigation, intensive case management, and on-site behavioral health support. The

proposal emphasizes collaboration with Caltrans and
leverages existing Homekey housing resources.

ERF Program Funds Awarded:	\$1,670,000.00
Funded Activities:	Proposed activities include modular interim/permanent housing and trauma-informed behavioral health care for 50 individuals along a 3.5-mile bay path with a focus on mixed interim and permanent housing in a community setting.

ERF Program Funds Awarded:	\$4,731,300.01
Funded Activities:	The City of Oakland will build and operate a 2-year cabin village for 100 individuals which includes job opportunities with behavioral health services via county providers.

Funded Activities:	The City of Oakland was an ERF 1 recipient. This ERF 2L award of \$3.6M is in addition to the partial ERF 1 award of \$4.7M to fulfill their original request for a total of \$8.3M. Under its ERF 1 award, Oakland pursued interim housing site preparation for 100 people with the plan to provide services to 50 persons. The funding from ERF 2L enables service delivery to an additional 50 persons bringing the total to 100 persons served in alignment with the original application.

ERF Program Funds Awarded:	\$1,168,774.00
Funded Activities:	The City of Montebello's award will serve 65 individuals in a wildfire-prone area, deploying a 5-person team with housing supports, while a new fire department outreach team establishes community presence. The team and housing supports include a housing navigator, non-congregate shelter through motel vouchers and/or tiny homes, and housing support funds (rental assistance, deposits, utilities, etc.).

options and provide housing connections and rental

The proposal encompasses a range of permanent housing options, including partnerships for seniors and people with behavioral health issues. ERF 2R funds will be used for a range of noncongregate shelter, rapid rehousing and permanent housing strategies, including acquisition of 4-bedroom homes.
