Our target area of encampment(s) lies between Highland Boulevard and Western Avenue running West to East, and between Franklin Avenue to Santa Monica Boulevard running North to South. Within our identified service area, we know of 113 people experiencing street homelessness residing in tents, makeshifts, vehicles, and on the pavement. This information has been obtained by direct outreach conducted by CD13 staff in conjunction with regional homeless outreach teams. Our target area's largest demographics include LGBTQ individuals and transitional aged youth (TAY). These individuals are usually single adults who are in need of wrap-around services including substance abuse and mental health treatment, vocational and employment support, and housing navigation. A large number of the homeless individuals within the area are connected to the coordinated entry system and are considered chronically homeless.

Briefly describe the prioritized site in relation to the larger encampment area. (1000-character limit)

Our prioritized site is the densest homeless population in our district and all of the locations listed under Encampment Information 3 are very close in proximity to one another, share community and association with one another, and constantly shift from location to location within the prioritized site. In relation to a larger encampment area, many more encampments exist in the adjacent East Hollywood, Melrose Hill, and Rampart Village neighborhoods.

Encampment Information

Hollywood hosts one of the densest and most diverse groups of homeless individuals in the country. Our target area of encampment(s) lies between Highland Boulevard and Western Avenue running West to East, and between Franklin Avenue to Santa Monica Boulevard running North to South. Within our identified service area, we know of 113 people experiencing street homelessness residing in tents, makeshifts, vehicles, and on the pavement. This information has been obtained by direct outreach conducted by CD13 staff in conjunction with regional homeless outreach teams. 2. Briefly describe physical characteristics of the prioritized encampment site in which the people you are proposing to serve are residing. The description must include the specific location, physical size of the area, the types of structures people are residing in at the site, whether vehicles are present, and any other relevant or notable physical characteristics of the site. The service area is located within our council district and is in the core of Hollywood. The boundaries lie within Highland Ave to the west and Western Ave running northwest to southeast, and Franklin Ave to the North. We see 3 main forms of encampment within this zone, including larger encampments with multiple tents or structures (20 tents), single individuals rough sleeping on the sidewalks, or vehicle dwelling (vehicles and RVs). In Los Angeles, vehicle dwelling was up the largest percentage last year and is evident in this zone. Our largest interconnected encampments follow the corridors, specifically along Hollywood Blvd, Sunset Blvd, Highland Ave, and Vine St. These encampments are easily accessible to one another and the individuals often move back and forth between regular and long standing sites.

3. Why is this encampment site being prioritized? Applicant should identify any distinguishing needs and/or vulnerabilities of the people living in this encampment and/or any health, safety, or other concerns that led the applicant to prioritize this site over other encampments. (1000-character limit)

The encampment site has the densest homeless population in CD13. Encampments within the area are made of makeshift structures that expand to block lengths and are difficult to keep clean and healthy for the homeless individuals living here. This resource will primarily serve our LGBTQ and TAY populations and provide them access to wrap-around services including hygiene, housing navigation, and interim and permanent housing referrals, and prevention and diversion for those at risk of homelessness. The area also experiences the highest eviction rates in the city and we expect continued entry into homelessness in the area. Homeless individuals resort to constructing makeshift shelters in high density areas, including along the 101 Freeway in the public rights of way under CalTrans jurisdiction. The 101 Freeway is one of the busiest in Los Angeles - which has proved to be hazardous to motorists and the homeless. A letter of support from CalTrans is attached to this application.

Proposal's Outcomes

5. What outcomes does this proposal seek to accomplish by 6/30/2027? Outcomes should be specific, measurable, attainable, relevant, and time-bound (SMART). (1000-character limit)

We expect our outcomes to be based on interim housing referrals and placements, services including vital documents needed to obtain permanent housing and employment, and overall access to a location where individuals can access the county's Continuum of Care through LAHSA and its partners. Our Outcomes: 1. Moving homeless individuals towards permanent housing with a housing-first approach. We expect to see 500 interim housing placements over the grant period with many more interim housing referrals placed over that period. 2. We will prepare individuals by getting them documents ready so they are prepared for permanent housing and employment resources - it would be realistic to expect upwards of 500 documents to be provided to our population (IDs and birth certificates). 3. We will give our target population access to hygienic services, mental health services, and substance abuse services with thousands of these services provided each month. 4. We expect 160 permanent housing placement

6. What are the primary activities the applicant will implement to achieve each of the proposal's outcomes? (1000-character limit)

CD13 staff has engaged with government agencies, nonprofit partners, community groups, as well as homeless individuals to bring this project to life and ensure its success. We have developed a detailed scope of work and have identified the primary service providers for the site to operate and carry out the key functions of the program. We currently hold monthly meetings with providers throughout our district to gather data on how programs are performing, we will meet with our Refresh Spot providers and do the same. We will additionally integrate "Connect Days" with other partners to bring in additional resources and expand the program capacity, and will implement an ongoing community advisory team to allow for transparency and involvement - including those with lived experience. Our staff meets with homeless advocates (many with lived experience) on a biweekly basis to discuss their concerns for living conditions at interim housing and hotels sites, as well as their experiences with LA

7. How will the applicant measure progress towards the proposal's outcomes? (1000-character limit)

Measurement data will include the following: 1. Number of individual engagements, 2. Number of referrals completed, 3. Number of linkages to psychiatric and substance abuse treatment 4. Number of interim housing placement and 5. Number of permanent housing placements. The council district seeks to work with well established and trusted service providers in the area to track the progress of major encampments and work collectively as a system to produce results in reducing homelessness at our targeted encampments. The voices of the homeless individuals will always serve as a guide to program design, allowing them to provide feedback on the quality and impact of services.

8. Are there any local ordinances, resources, or other factors that may hinder achieving the proposal's outcomes? If so, how will the applicant navigate these challenges? (1000- character limit)

Services similar to our proposed program have had community and neighborhood pushback in the past. People have shown concern for homeless programs opening and attracting encampments or other similar issues. This would be our primary hindrance, though the community has been receptive to the idea in community meetings and through discussion in recent months. We plan to involve the community as much as possible, and would hold meetings and open houses for anything we receive through the state. We also plan to strongly partner with community organizations who have already signaled willingness to participate in collective action and new approaches to homelessness at the proposed encampments in Hollywood.

Centering People

10. Describe how the perspectives of people with lived experience of homelessness meaningfully contributed to the content of this proposal? How will people with lived experience be part of the implementation of this ERF project? If individuals living in the encampment site were included in the development of this proposal, describe how their input was obtained and how that input shaped the proposal. (1000-character limit)

The proposed project is supported by a culmination of information gathered by CD13 through direct outreach to residents of the identified encampments over the past several years. Our team directly works with many of the individuals within the proposed service area. We will continue to engage encampment residents employing the most recent evidence-based practices to gauge appropriate needs and program building and implementation, and homeless individuals on our advisory team. Our office has and continues to hold advocate meetings with neighborhoods throughout our district including Hollywood, and we currently engage with homeless individuals or those with lived experience in those meetings. Additionally, we'll lean on feedback provided to the operator of the original Refresh Spot in Skid Row (HHCLA), who has years running a similar successful program.

11. Briefly describe how the proposal exemplifies Housing First approaches as defined in Welfare and Institutions Code section 8255. (1000-character limit)

Our project design incorporates housing navigation to assist with entry into housing navigation at our interim housing locations listed on Table 1, finding permanent housing (PSH), and securing permanent housing through the Coordinated Entry System (CES) through the Continuum of Care (CoC). Additionally, we would provide a number of serves that would increase self-sufficiency, build participant confidence, and give them choice in what routes they seek. This will be done through access to showers, laundry, device charging, and more. When housing options become available, our project will be a springboard towards finding housing, avoiding housing discrimination based off of appearance and lived experiences, and be a brick and mortar location our homeless neighbors can rely on when they're ready to pursue a number of resources.

12. Describe how each of the following service delivery practices are incorporated into the outreach, interim shelter (if applicable), and permanent housing aspects of the proposed ERF project: (a) individual participant choice and (b) trauma informed care. (1000-character limit)

Our office strongly believes in empowering our homeless neighbors and we support motivational interviewing, housing first, and harm reduction practices (including the whole of trauma informed care). Case management and housing navigation would be trained with these practices in order to place emphasis on the homeless individuals' needs and work with them where they're at. This resource will be a low-barrier approach, which will work with many subpopulations including those who are chronically homeless, and will operate on a regular schedule which allows for consistency, follow-through, and trust. We will seek to partner with trusted organizations that provide support for SUD, MH concerns, and many other needs who have training in the practices listed above. We feel that Hollywood has the community of providers to support a diverse array of participants through this project and the willingness to partake in the project.

13. Describe how harm reduction principles will be incorporated into the outreach, interim housing (if applicable), and permanent housing aspects of this ERF project. (1000-character limit)

The project will partner with agencies that practice harm reduction in their current day-to-day work and newly hired staff will be required to receive training on harm reduction and trauma informed care principals. Any outreach, case management, or housing navigation will operate under the most recent evidence-based practices, and will work with the individuals enrolled in housing navigation to find positive outcomes that bring them closer to permanent housing. A sharps disposal bin (as well as other types of disposal bins if applicable), as well as safe cubbies or lockers will be available on the site as well.

14. Describe the services that will be provided to improve people's health, dignity, and safety while they continue to reside within the prioritized encampment site. (1000-character limit)

Harm reduction supplies, showers, bathrooms, laundry, charging stations (reduce reliance on tapping power poles), and an open air/open layout to allow for inclusivity and a tolerant atmosphere. Overall consistent access to services will be made available in Hollywood, benefitting all who choose to utilize the site. Community spaces will be incorporated to increase a sense of belonging and cooperation in service delivery. Currently, the Hollywood area, despite its large unhoused population, has very few community focused spaces like this.

15. Identify what controls are or will be in place to ensure that all ERF-3-R funded parties will not penalize homelessness. The term "penalize homelessness" means to impose, by a governmental unit, criminal or civil penalties on persons who are homeless in a manner that is related to those persons' engagement in necessary human activities, including sleeping, resting, and eating. (1000-character limit)

Councilman Hugo Soto-Martínez does not support any City ordinance that results in criminalization of homelessness. Our program will reduce discrimination, reduce the risk of arrest of homeless individuals, reduce homelessness being treated as a crime, reduce overall stigma and harassment of homeless individuals, and reduce the likelihood of people calling law enforcement to solve homelessness. A Hollywood Refresh Spot would serve as a resource for law enforcement to utilize when in need and allow law enforcement to build trust with homeless individuals by directing them to resources opposed to having no resources when needed - this site will help LAPD and other law enforcement agencies deescalate many situations. Additionally, CD13 and Refresh Spot partners will work with the Mayor Office's non-crisis response program CIRCLE to circumnavigate difficult situations.

16. Describe how this proposal considers sanitation services for people residing in the prioritized encampment. This may include but is not limited to non-intrusive, curb-side waste removal and access to clean and available bathrooms. (1000-character limit)

Our council district currently assigns LA Sanitation to homeless encampments through Cleaning and Rapid Engagement (CARE) and CARE+ cleaning operations, conducted by the City of Los Angeles Bureau of Sanitation (LASAN) to encampments within the service area. We do not seek to remove encampments through LASAN and treat the resource as cleaning related to public health. The proposed ReFresh site funded through this grant will provide a safe location while LASAN conducts their normal operations. The proposed project will allow for a safe place for homeless individuals to receive showers, laundry, and other resources while comprehensive or minimal cleanings are conducted within the service area.

This site will include open access to clean and available restrooms, showers, and laundry.

Part 3: IMPLEMENTATION

Core Service Delivery and Housing Strategies

17. Describe the proposed outreach and engagement strategy, case management, and / or service coordination for people while they are continuing to reside within the encampment site. Quantify units of service to be delivered including the ratio of staff to people served, frequency of engagement, and length of service periods. (2000-character limit)

We propose a housing navigation team based out of the Refresh Spot Hollywood Site to conduct field operations at identified encampment sites. This team would include case management and refer people to interim and permanent housing sites in Los Angeles City and County through the Homeless Management Information System (HMIS) through the Coordinated Entry System (CES). Additionally, the team would partake in regional coordination to ensure no duplication of services or service gaps at encampments in the identified zone. This regional coordination includes communicating with the LAHSA Outreach Coordination (OC) team within the Service Provider Area (SPA) level.

For a team of two housing navigators, 50 individuals will be engaged (enrolled in a service program) and each team will provide intensive case management to 25 individuals. The service period will fit the requirements of the CES (90 days) with opportunities to extend or re-enter the program based on engagement and readiness for further services.

The site case management will conduct a warm handoff of participants at the accepted interim housing site within our district. In some cases, a change in nonprofit provider may occur and the Refresh Spot staff will assist in the intake process for a site. Case management is expected to meet weekly to review a participant's treatment and housing plans - whether it be at the Refresh Spot Hollywood or in interim housing.

18. Describe the role of Coordinated Entry in the context of this proposal and how Coordinated Entry policies or processes will support and / or hinder the implementation of this proposal. (1000-character limit)

CD staff partners with the Coordinated Entry System (CES) and trusts established long-standing providers in Hollywood. The proposed project seeks to supplement the existing system with additional outreach and on-site housing navigation staff. Service coordination will include working with SPA 4 leads to match participants with permanent housing. Providers can use the proposed project site to build trust and rapport with their participants by providing scarce services such as showers, laundry, and housing placements in one location. Homeless individuals within the service area will have consistent access to the resources in this low-barrier entry environment, allowing for stability in their lives. This stability will also allow outreach teams to find participants if they've been MIA. Opposed to only finding folks at encampments, the Refresh Spot would allow for another place to find their participants or share messages should they be seen.

19. Describe each of the specific (a) interim housing and (b) permanent housing opportunities that will be used to achieve the proposed outcomes of this ERF project. Demonstrate that any ERF-3-R funded interim housing capacity is either non-congregate or clinically enhanced congregate shelter. (2000-character limit)

Our Council District oversees 9 Interim Housing sites. Our sites includes Isaiah's House - a men's shelter in Hollywood (30 beds), Tiny Homes Echo Park - non congregate and available for all populations (34 beds), Tiny homes Westlake - non congregate and available for all populations (71 beds), A Bridge Home Schrader - available for men and women (72 beds), A Bridge Home YWCA - a non congregate women's shelter with shared bathrooms (94 beds), A Bridge Home Gardner - a women's shelter (30 beds), The Nest - A non congregate site available to men and women (36 beds), and the Jan Clayton Center for men (52 beds). Our district also hosts Hollywood 2.0, a mental health collaborative that has placed a number of mental health beds in Hollywood that we would seek to place Refresh Spot participants in through collaboration with the county and LA County Department of Mental Health (DMH).

20. Demonstrate the applicant's commitment and ability to deliver permanent housing solutions to the people residing in the prioritized encampment, including by providing examples of prior successful efforts to permanently house similarly situated individuals. (2000-character limit)

Our team has successfully housed individuals from encampments in our district and in previous roles on a case-by-case basis going as far as searching for single units for individuals. The map provided with this proposal is a living document our team maintains outside of the proposal that's used to better understand our homeless population and coordinate services to secure permanent housing.

Our team works with the Mayor's Office and County agencies to conduct encampment to home projects regularly-bringing folks into programs like SHARE collaborative housing and Inside Safe. We also directly contract with People Assisting the Homeless (PATH), who we use to prioritize individuals for housing navigation and permanent housing placement regularly. Our office supports Mayor Bass's Executive Directive 1 in building more permanent housing in Los Angeles. Our homelessness team regularly meets with our Planning team and the Mayor's Office to discuss ED1 projects and how to collaborate further between teams and offices to fully utilize new sites. Our office has also been actively pursuing new sites through the LA Alliance lawsuit, designating half of the available resources for permanent and permanent Supportive Housing. Additionally, we work closely with the coordinated entry system to ensure our homeless neighbors are document ready, and that they're being prioritized for county-level housing resources through the matching process when new units come online through Measure HHH.

21. Describe how this proposal is tailored to meet the needs and preferences of people residing within the prioritized encampment. (1500-character limit)

Hollywood has a very dense and diverse homeless population. In Los Angeles, Hollywood has the second most dense homeless population in the city. Our service area also hosts large TAY and LGBTQ populations; the two populations we seek to primarily serve. A Refresh Spot will be a low-barrier and accessible site homeless constituents can visit to address their basic needs in a dependable location. A Refresh Spot would then provide referrals and placements to interim housing. The Refresh Spot will provide office space for service provider outreach workers to complete their referrals and develop housing plans. Charge station(s) at the location would allow for phone and device charging - helping them further access resources including their outreach team, case manager, housing navigator, health services, jobs, pet services, and more. Mail services would serve a similar purpose. The site will also feature harm reduction supplies, bathrooms, and showers for health and cleanliness. A. Hollywood and Taft (6 individuals, primarily single adults, possibly TAY). Our identified providers have a proven track record for serving TAY and LGBTQ populations, such as those at Lexington and Vine and Western and Sunset. They also staff individuals with lived experience to better connect with their serviced population.

22. Describe strategies the applicant will use to ensure that people are not displaced from the prioritized encampment into another unsheltered location. Include strategies that are in addition to/complement the interim shelter and permanent housing opportunities that are part of this proposal. (1000-character limit)

Already no attempt at displacement, determined effort to keep homeless individuals where they are for better case management and retainment of vital documents and belongings. We don't want a return to street scenario. This resource being nearby encourages folks to stay where they are.

23. Describe specific strategies and/or services the applicant will use to prevent returns to unsheltered homelessness among people from the prioritized encampment who are sheltered and housed through this ERF project. Include whether these strategies will be funded with ERF-3-R funds and, if not, what other resources will be leveraged. (1000-character limit)

We will continue to offer interim housing beds, along with other leveraged resources, to various individuals throughout the proposed catchment zone. We will continue to work within the Continuum of Care (the CoC), and the Mayor's Office and her Inside Safe program to bring people indoors and maintain a services-led and housing-first strategy. Our overall strategy is ensuring continuity of services throughout multiple adjacent encampments which are often socially connected. This means prioritizing other encampments outside of our proposed zone in order to ensure those individuals don't move into the area naturally over time. As with anywhere in our district, we won't seek to forcefully remove encampments outside of the proposed zone - which would risk moving individuals or groups towards previous encampment areas.

24. Describe how this proposal considers and plans for the dynamic nature of encampments including potential inflow of people into the geographically served areas. (1000-character limit)

The Refresh Spot and supportive services are open to homeless individuals to receive a shower, do their laundry, charge their devices, and receive case management services including housing navigation. Because the geographic area is slightly scattered, we would seek a location that remains accessible to the target population(s) to provide those folks services. This would not discriminate against others seeking services if they're new to the area. We expect inflow, fluctuation (movement), and broader encampment change due to Hollywood already being very dynamic for a multitude of reasons.

25. Describe how participants in this ERF project will be supported with continued access to, and storage of, their personal property while in the encampment, in interim housing (if applicable), and in permanent housing. (1000-character limit)

Our team contracts homeless outreach with a nonprofit agency who provides storage as a supplement service. We would be able to leverage these funds to store items for individuals who are matching to interim or permanent housing. Our team also leans on CoC homeless outreach teams to secure storage for those who need it and have done so successfully many times. We do not want a lack of storage for a person's belongings to be a barrier for entry into any form of housing.

26. Describe how participants in this ERF project who have service animals and/or pets will be supported while in the encampment, in interim shelter (if applicable), and in permanent housing. (1000-character limit)

The principal approach is working with Los Angeles County Dept of Health Services Multi Disciplinary Teams for Emotional Support Animal (ESA) verification when necessary - which they already regularly assist with, to ensure homeless individuals can bring their pets into permanent housing opportunities. All of our interim housing sites allow for pets and we strongly support LAHSA's implementation of this regional policy. Pets are family and we will work with them as part of the low barrier, motivational interviewing (MI), and housing first strategies. We'll also work with partner agencies like Public Council for spay/neuter and other pet services and businesses and PetSmart for food, cages, and other basic services. We'll seek to have the Hollywood Refresh Spot host these programs.

(1000-character limit) 8 interim housing (IH) sites and the CES in CD13 will be open to those who visit the Hollywood Refresh Spot and enroll into services when beds become available. Each site referenced in Table 1 will be resources for the housing navigators to refer to.

There are 13 PSH sites online or being developed in our district. Those sites will help the proposal's outcomes with direct matching to units from encampments, with being referred to those units through housing navigation at the Refresh Spot, or once matched from our IH sites listed in Table 1.

We'll also work with county programs to meet the proposal's outcomes. IH mental health beds will be available through our County Department of Mental Health and their Hollywood 2.0 project. Participants referred to DMH services will have opportunities to be permanently housed through DMH resources. Additionally, our housing navigators will be referred into programs like Housing for Health (HFH) with our county Department of Health Services (DHS).

Establishing a Hollywood Refresh Spot will give the residents of these encampments access to hygienic conditions, better access to services referrals such as ID vouchers, interim housing referrals, mental health and substance abuse resources, and more. Giving homeless individuals a location to access many of these services will allow our partner agencies to focus less time on street based engagement (ie: homeless outreach), and more time bringing interim and permanent housing online. The amount requested is directly based off of the current and tested Refresh Spot in Skid Row with the addition of housing navigation and direct access to LA's Coordinated Entry System (CES).

Our nonprofit partners will be SPA 4 CES agencies contracted through the Los Angeles Homeless Services Authority (LAHSA). These partners will include The Center, Homeless Healthcare Los Angeles (HHCLA), People Assisting the Homeless (PATH), The People Concern (TPC), and other TAY and LGBTQ Providers in Hollywood including the LGBT Center, MFP, HHPY, and Covenant House. The Center and Homeless Healthcare will be our chosen providers for our project. These agencies currently hold contracts with LAHSA and LA County Department of Health Services (DHS) who have numerous requirements for operating in homeless services in LA county. LAHSA and the CAO will administer contracts and expectations with The Center and HHCLA.

County government partners include LAHSA, Supervisor District 3 (SD3), Department of Mental Health (DMH), and DHS for homelessness, mental health, and substance use services. We'll also work with the Mayor's Office, The City Administrative Office (CAO), Council District 4 (CD4), General Services Division (GSD), and the LAPD. Our government partners will assist in site needs and additional services. We'll also work with community groups including but not limited to schools, The Hollywood Partnership, The Hollywood Chamber of Commerce, Hollywood 4WRD, SELAH, the Hollywood Food Coalition, neighborhood councils within the zone, homeless advocacy groups, and the homeless individuals residing within the catchment zone as part of community events and the advisory team.

33. Describe specific examples of how Local Jurisdiction(s) and the CoC have collaborated on the design and implementation of this proposal. (1000-character limit)

In 2023, CD13 hosted a meeting with a plurality of the partners listed in question 32 at the Refresh Spot in Skid Row including LAHSA, SD3, CD4, PATH, HHCLA, and the Mayor's Office. Many have also engaged in site tours for potential project locations and have shown partner interest in running a program similar to our project or show direct interest in participating including DMH, DHS, LAHSA, The Hollywood Partnership, The Hollywood Chamber of Commerce, PATH, neighborhood councils, and others. We have engaged all of the parties listed in question 32 in regards to the potential project and the concept is met with strong support.

Additionally, CD13 has met with HHCLA and The Center – both based out of CD13. HHCLA operates the original Refresh Spot in Skid Row and has provided ample feedback on the program and has expressed strong support and interest in partnering at the site. The Center is rooted in Hollywood and has edited and reviewed this proposal along with our other partners.

The encampments within the catchment zone are on public right of way (i.e. sidewalks or public land), which our office (the City of LA) has the right to and control over. Some encampments within the zone sit on vacant lots, and it's believed individuals are in vacant properties throughout the zone as well. We're in touch with most property owners in our district. Homeless individuals within the specified encampments will greatly benefit from the implementation of a Hollywood Refresh Spot. The site will allow for healthier streets and healthier homeless individuals as we continue to pursue a strong reduction in homelessness as people are housed. I am writing on behalf of the Los Angeles Homeless Services Authority (LAHSA) and the Los Angeles Continuum of Care (LA CoC), to express our strong support for the City of Los Angeles, Council District 13's (CD 13) application to the Encampment Resolution Funding (ERF) Grant Program, Round 3, Lookback Disbursement, to address the critical needs of people residing in street encampments in and around Hollywood, California, where there are high numbers of particularly vulnerable populations (Transitional Aged Youth and LGBTQ+ community members, many with comorbid Substance Use Disorder and/or Mental Illnesses) experiencing unsheltered homelessness. This would be accomplished by establishment of a drop in "Refresh Spot" modelled on an existing project in Los Angeles' Skid Row.

LAHSA is a joint-powers authority of the City and County of Los Angeles and serves as the lead agency in the LA CoC. LAHSA is responsible for working alongside City and County partners to engage, house, and provide supportive services to individuals and families experiencing homelessness in Los Angeles County. As such, LAHSA strongly supports encampment resolution efforts that bring additional housing resources to our region's most vulnerable people experiencing homelessness.

The proposed project in CD 13 would prioritize 200 people currently residing in an identified catchment zone and can serve over 1,000 unique individuals over the grant period. The Refresh Spot would provide vital service connections for the prioritized population, including but not limited to hygiene supports, water and cooling in the summer months, Interim Housing placements, and referrals for mental health and substance use disorder treatment. Projects like these fill crucial system gaps in Los Angeles, and the Hollywood location would be ideal as this area has a dense concentration of homelessness in several key corridors. LAHSA is deeply appreciative of CD 13's efforts to provide services and an additional access point in Hollywood utilizing the ERF funding.

LAHSA fully supports CD 13's plan to build another pathway to services for the highly vulnerable unsheltered populations in their district, and we are confident that with the ERF funds, CD 13 District Leadership and Staff are highly capable of carrying out this initiative with great success.

I write in support of the request for funds for City of Los Angeles Council District 13 (CD13) through the State's Encampment Resolution Funding (ERF) Grant Program through its third round of disbursements for Refresh Spot in Hollywood. The project is modeled after the Refresh Spot in Skid Row, which has a long track record of providing 24/7 support to the unhoused population of Skid Row. This site will include case workers and housing navigators and provide linkage to interim housing and basic needs such as bathrooms, showers, laundry, harm reduction materials, and more.

CD13 is working closely with two well established service providers who will be the operators of this site, Homeless Healthcare LA, and The Center in Hollywood. 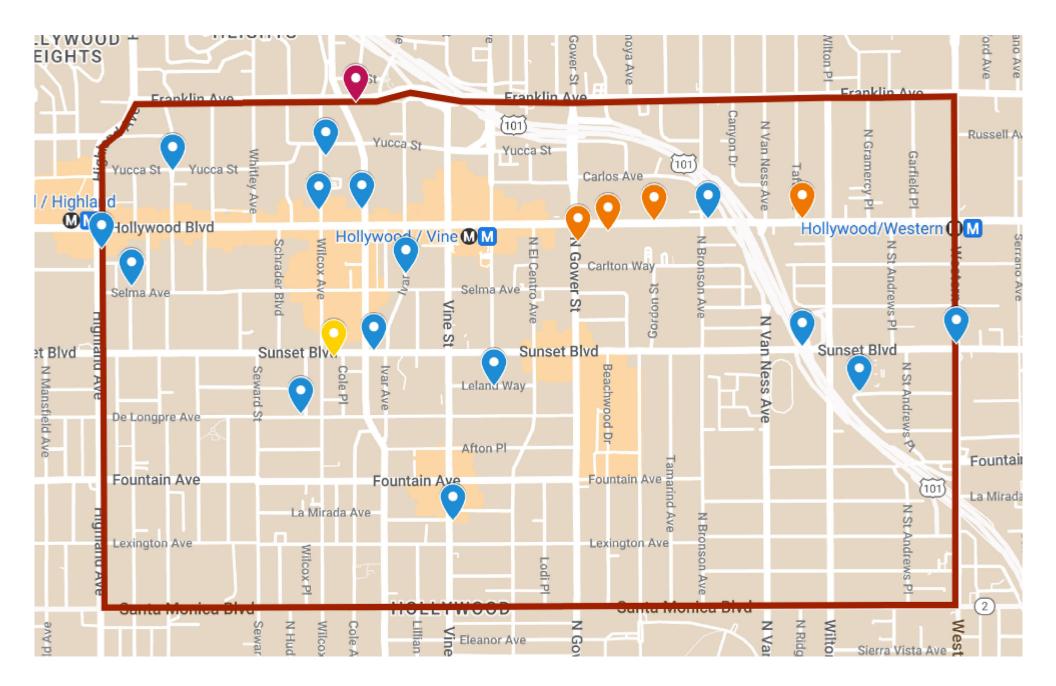
