## 1. Homelessness Response System Gaps Assessment

When determining local funding priorities, it is critical to understand the current gaps in the local homelessness response system. Each community faces unique challenges in reducing and ending homelessness, so an assessment of current resources and understanding the needs yet to be fulfilled is critical to ensuring the effective and efficient use of new resources. This can be done in various ways and can include conducting a community needs assessment, holding local public forums, talking with service providers and people experiencing homelessness, and utilizing <u>HUD's seven system-level performance measures</u> that help communities gauge their progress in preventing and ending homelessness.

Homelessness Response System Gaps Question 1a - Begin Answer Our tri-county continuum uses several different tools to determine the local gaps in housing services, including HUD's homeless Pointin-Time count, Longitudinal Systems Analysis, Stella tools, and HMIS Annual Performance Reports. In addition, each county completed a No Place Like Home Homeless plan that reflects a county-wide collaborative process that includes community input and stakeholder engagement to address homelessness. Homelessness Response System Gaps Question 1a - End Answer

 b. How people with lived experience of homelessness had ongoing meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they have meaningful opportunities to inform all levels of system planning over time;

Homelessness Response System Gaps Question 1b - Begin Answer Each of our local continuums in our Regional Continuum of Care have persons with lived experience of homelessness. These individuals regularly participate in monthly meetings to go over available services and engage in funding discussions to address homelessness in our communities. Our continuum is exploring different outreach methods to reach persons with lived homeless experience who might live in remote areas where broadband internet services are limited. Counties frequently perform needs assessment throughout our communities to gather feedback and encourage our homeless to provide much needed input. Homelessness Response System Gaps Question 1b - End Answer

c. How organizations that have historically served communities of color but may not have previously participated formally in the CoC and may not be a part of the homelessness provider community had meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they will be engaged in system planning over time;

Homelessness Response System Gaps Question 1c - Begin Answer The three counties in our CoC are situated in a rural area of Northern California. With exception to the Native American reservations, our communities are not segregated by race, but rather socioeconomic factors. We have strong liaison relationships with each of the Native American reservations in our continuum and continue to strengthen those relationships and connect our Native American population to supportive services that are available.

Both Colusa and Glenn County have a large Latinx population in their counties. We prioritize hiring staff with culturally diverse backgrounds and individuals who have gained self-sufficiency after experiencing homelessness and/or housing insecurity. By having a well-rounded staff and an increased presence in cultural venues we hope to gain more participation and engagement from a sometimes underserved population.

Dos Rios follows the best practices of Housing First and does not discriminate against any individual based on the status of race and/or ethnicity. We apply a "trauma informed" approach when working with our customers to prevent additional trauma unnecessarily. We do this through warm handoffs and referrals to additional services with our partner agencies. Information is always shared in our customers preferred language to make them feel more comfortable and understand the resources and services available. We continue to solicit feedback from our customers to ensure that we are creating sustainable solutions to help them achieve successful outcomes.

Homelessness Response System Gaps Question 1c - End Answer

d. How gaps were assessed for special populations such as families, youth, victims of domestic violence, seniors, persons who have been convicted of a crime, persons with a disability, persons who are chronically homeless, persons with HIV/AIDS, persons who are LGBTQ, veterans, persons with limited English proficiency, and persons who are undocumented;

Homelessness Response System Gaps Question 1d - Begin Answer Our annual Point in Time report captures those special populations and allows us to look at trends and allow our housing partners to shift focus based on the current demand. We recognize that there is often an under-reporting element as some persons will not selfdisclose that information in the first line of engagement. When further assessments are performed, we are usually able to gather that important information and ensure that information is reported into our HMIS data system. We also utilize data from our LSA to also identify any special

populations to see if increased outreach efforts could connect those individuals.

e. How racial or ethnic disparities in the delivery of homeless services were assessed;

Homelessness Response System Gaps Question 1e - Begin Answer Though each county has a slightly different homelessness population, we have not experienced a disparity in the delivery of homeless services. We have a diverse staff that can appropriately engage with persons that enter into our homeless response system. Homelessness Response System Gaps Question 1e - End Answer

f. How frequently gaps assessments are conducted;

Homelessness Response System Gaps Question 1f - Begin Answer Our CoC performs a gaps assessment annually during the month of February. We review

information gathered from our local Point in Time Count and Housing Inventory Count to determine our gaps and take inventory of the housing supports that exist in our counties. There are two transitional housing programs, no permanent supportive housing subsidies, and few housing service providers in our continuum. Each county is working towards increasing the options for our most vulnerable.

g. How findings are used to make informed decisions for funding projects within the community; and

Homelessness Response System Gaps Question 1g - Begin Answer As the regional layout and population differs for each of the three counties in the continuum, each county performs a local gaps assessment for their individual county that identifies the housing intervention/service gaps that exist in their county. Each county uses their local CoC Stakeholders group as a resource to gather this information.

The Dos Rios executive board then compiles information from our regional continuum to assist in planning for future and current allocations available. The gaps assessment allows our continuum to develop short and long-term strategies to move towards our effort to alleviate homelessness in our communities.

Homelessness Response System Gaps Question 1h - Begin Answer Glenn County is the lead applicant and will be responsible for providing grant administration and oversight for the HHAP-2 allocation. Glenn County submits quarterly progress reports to the sub-recipients and can determine if adjustments are needed to address the gaps in the homelessness response system over the lifecycle of the grant.

Homelessness Response System Gaps Question 2a - Begin Answer Housing studies were performed in Colusa, Glenn, and Trinity Counties in January 2020, July 2019, and March 2019, respectively. The 2019 Point in Time counted 196 individuals and 142 households experiencing homelessness in the Dos Rios region. Of these individuals:

Of the 196 persons, 113 identified as male, 83 identified as female, and no one identified as transgender.

151 individuals were adults over the age of 24, 6 individuals were ages 18-24, and there were 36 children under the age of 18. 15 individuals identified themselves as Veterans.

9 adults had a serious mental illness, 9 adults had substance abuse disorders, and 15 adults were identifies as having a disabling condition.

In terms of race 172 persons identified as White, 3 persons identified as Black or African-American,4 persons identified as Asian, 18 persons identified as American Indian or Alaska Native, and 1 person identified as Native Hawaiian or other Pacific Islander. 40 persons identified their ethnicity as Hispanic of Latino 6 individuals identified themselves as Victims of Domestic Violence. [Dos Rios CoC, CA-523 uses several different funding sources to address homelessness within our jurisdiction. Some of the funding sources are targeted for a specific population, but during assessment of each homeless individual, our providers determine appropriate funding to address their individual housing needs. The following are funding sources that address homelessness in our

jurisdiction:

Homelessness Response System Gaps Question 2a - End Answer

b. Data and qualitative information showing any gaps or disparities in access to services, delivery of services, and housing placement and

housing retention outcomes for special populations such as families, victims of domestic violence, seniors, youth and young adults, persons who have been convicted of a crime, persons with a disability, persons who are chronically homeless, persons with HIV/AIDS, persons who are LGBTQ, veterans, persons with limited English proficiency, and persons who are undocumented;

Homelessness Response System Gaps Question 2b - Begin Answer Through evaluations and assessments, the following challenges and barriers to delivery of services were identified. The most frequently cited barriers and challenges included:

 There are not enough affordable housing options throughout the Dos Rios region. Rental vacancies from 0.6%- 3% within Colusa, Glenn and Trinity County and available units do not meet household needs (# of bedrooms).

2. There are inadequate levels of housing type resources, for example emergency shelter, transitional housing, assisted living environments and permanent supportive housing. Homelessness Response System Gaps Question 2b - End Answer

 Data and qualitative information showing any racial or ethnic disparities in access to services, delivery of services and housing placement and housing retention outcomes of homeless services;

Homelessness Response System Gaps Question 2c - Begin Answer Racial demographics of the homeless populations remain consistent with the racial demographics with the Dos Rios Region as a whole.

Homelessness Response System Gaps Question 2c - End Answer

d. Any other disparities that were found in the delivery of homelessness services including rates of successful permanent housing placements, and housing retention rates;

Homelessness Response System Gaps Question 2d - Begin Answer Of the 143 households identified as homeless, 40 are chronically homeless. Of the 196 individuals, 46 are chronically homeless. Lack of income, lack of affordable housing and mental health and substance abuse are noted as the primary reasons for homelessness. There is a lack of housing opportunities for people recovering from and dealing with substance use disorders. Persons who remain a high-risk for housing failure due to a lack of participation in behavioral health recovery once they are housed. Large geographical area, coupled with restricted transportation resources for the target population, contribute to the financial instability of a participant and increases the risk for loss of housing. Homelessness Response System Gaps Question 2d - End Answer

## 2. Regional Resources Planning

When working within the homelessness system, it is critical to assess the current resources available within the community to ensure any new resources are most effectively and efficiently targeted to best serve people experiencing homelessness within the community. Given the high number of people experiencing homelessness in California and the unprecedented amount of federal and state funds available to address homelessness, HCFC expects applicants to coordinate all available funding to safely shelter and permanently house as many people experiencing homelessness in the applicant's community as possible, with a particular focus on rehousing individuals currently living in Project Roomkey (PRK) sites.

Regional Resources Planning Question 1 - Begin Answer The Homelessness Response Local Investment Plan was an important and helpful tool to allow each county, individually and as a three county continuum, to look more strategically at all funding in totality. This allowed our CoC to explore the most impactful way to address the current needs of our homelessness and to leverage funding to achieve the maximum success. Our Dos Rios Executive Board meets monthly to discuss current and future funding opportunities and how funds can be leveraged to be the most impactful to our homelessness in our region. Additionally each county's local CoC /Community Stakeholder's Committee convene regularly to go over available services and funding to bolster our crisis response system around homelessness. ## 3. HHAP-2 Funding Plans

Dos Rios does not plan to utilize HHAP-2 funding for Project Roomkey permanent housing pathways. Emergency Solutions Grant Coronavirus funding, Project Roomkey Rehousing Strategy Funding and other local funding resources will be utilized to quickly transition persons from noncongregate shelter into permanent housing solutions. Glenn County Community Action Department is the lead applicant lead administrative entity for the continuum. The administrative costs allowable will be approximately \$7000 per fiscal year for the HHAP-2 grant and responsibilities will be between our CoC Coordinator (5% FTE) and an Administrative Coordinator position (5 % FTE). The percentage of time will fluctuate from year to year during the grant lifecycle depending on each fiscal year's projected expenditures.

Grant administration needs will differ for each sub-recipient and the lead agency will monitor progress.

The percentage of time will fluctuate from year to year during the grant lifecycle depending on each fiscal year's projected expenditures.

HHAP-2 Funding Plans Question 3b - Begin Answer Glenn County Community Action will utilize our Housing Manager, Fiscal Program Manager, and Administrative Manager and team to administer the funding and ensure compliance with reporting responsibilities. The Dos Rios Coordinator position is used to bridge communication amongst the three counties and provide assistance to each county for their planned expenditures.

Through the Continuum of Care, needs are assessed, and these resources are allocated equitably. The three counties in the consortium are relatively similar in size and population with varying number of homelessness that can depend on the season. The CA-523 Dos Rios CoC Executive board agreed that the allocation be split equally between the three counties.

The Glenn County Community Action Department has been working with the Glenn County Behavioral Health Department to develop a Supportive Services Plan for our No Place Like Home Housing Development Project. We have a partnership with a Housing Developer, Rural Community Housing Development Corporation, to bring a No Place Like Home permanent, supportive housing complex to Glenn County. Per our Housing Study, the county currently lacks smaller 1-2 bedroom units, so the developer plans to build a 30-40 unit complex to address the county's need. The NPLH housing project will designate approximately half the units for low-income individuals/ families and half the units for those who need mental health supportive services, with 1 unit reserved for a property manager. Glenn County hopes to apply for Round 4 of the competitive NPLH funding. In order to make our application competitive, our housing developer has identified a \$500,000 gap in funding, and these funds will help us close that gap. Glenn County is still experiencing the aftermath from the Carr and Camp Fires in 2018, and we have a shortage of available housing units at all levels. Currently, folks experiencing homelessness are from all walks of life, not just certain racial backgrounds. We are excited about the opportunity to bring a NPLH supportive housing development to the county, as this would provide housing for those needed severe mental health services. We currently have to send most of those folks out of the county for housing, and this would provide an opportunity for them to stay in county both to live and receive services.
