1. Homelessness Response System Gaps Assessment

When determining local funding priorities, it is critical to understand the current gaps in the local homelessness response system. Each community faces unique challenges in reducing and ending homelessness, so an assessment of current resources and understanding the needs yet to be fulfilled is critical to ensuring the effective and efficient use of new resources. This can be done in various ways and can include conducting a community needs assessment, holding local public forums, talking with service providers and people experiencing homelessness, and utilizing <u>HUD's seven system-level performance measures</u> that help communities gauge their progress in preventing and ending homelessness.

Homelessness Response System Gaps Question 1a - Begin Answer The assessment and identification of housing needs and determining gaps in the Butte County region starts with HUD's homeless Point-in-Time count and Housing Inventory Count. Using this data along with our Coordinated Entry Queue data and Longitudinal Systems Analysis gives our CoC baseline data to use when we hold public forums and talk with local service providers and people experiencing homelessness. The most recent Gaps Analysis was completed in 2019 with assistance from The Technical Assistance Collaborative (TAC). Currently, as we navigate the ongoing effects of the COVID-19 pandemic, we have relied on data collected previously and

targeted email survey's sent to our community CoC members. Using survey monkey our CoC membership was surveyed to determine service gaps which could be funded with HHAP-2 funds. It is anticipated that a more thorough Gaps Analysis will be completed once the COVID-19 pandemic ends.

Homelessness Response System Gaps Question 1b - Begin Answer Our local CoC is comprised of diverse organizations, and thus offers a broad array of knowledge about homlessness, including participation from people with lived experience of homelessness. Strategic approaches have included identifying the partners within the CoC who are best situated to network, and get people with lived experience of homelessness to participate in our ongoing assessments of local needs and gaps in services. Meaningful opportunities to inform all levels of system planning are provided, such as training volunteers to become trained surveyors who interview persons during the PIT. Encouraging participation on our local CoC, and other organizations throughout the jurisdiction such as the Greater Area Chico Homeless Task Force. Recently, special attention has been given to ensuring that our electronic surveys, sent out on behalf of the CoC for suggestion on funding prioritizations, reach this important aspect of our community. The CoC's marketing strategy includes direct outreach to people on the street and other service sites, informational flyers left at services sites and public locations, utilizing Butte 2-1-1's "Be Home" mobile application, announcements during CoC and/or other coalition meetings such as the Greater Chico Housing Task Force and providing educating presentation to mainstream service providers. c. How organizations that have historically served communities of color but may not have previously participated formally in the CoC and may not be a part of the homelessness provider community had meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they will be engaged in system planning over time;

Homelessness Response System Gaps Question 1c - Begin Answer The CoC and our partners such as Butte Community College and The California State University, Chico, hold ongoing recruitment and outreach efforts to enlist organizations that have historically served communities of color but may not have previously participated formally in the CoC and may not be a part of the homelessness provider community. When organizations are identified, they are often included in CoC community emails, are recipients of CoC related surveys, and receive direct outreach by members of the CoC.

When opportunities to gather important data, used in analyzing community service gaps, such as local public forums and electronic surveys, strategic approaches are used to get these organizations involved. Efforts are made to identify partners within the CoC who are best situated to network, and get individuals from these organizations involved that may not have previously participated "formally" to participate in our ongoing assessments of local needs and gaps in services.

Meaningful opportunities to inform all levels of system planning are provided, such as training volunteers to become trained surveyors who interview persons during the PIT, encouraging participation on the local CoC, and other organizations throughout the jurisdiction such as the Greater Area Chico Homeless Task Force. Special attention has been given to ensuring that these organizations receive notification from the CoC.

d. How gaps were assessed for special populations such as families, youth, victims of domestic violence, seniors, persons who have been convicted of a crime, persons with a disability, persons who are chronically homeless, persons with HIV/AIDS, persons who are LGBTQ, veterans, persons with limited English proficiency, and persons who are undocumented;

Homelessness Response System Gaps Question 1d - Begin Answer Gaps were assessed for special populations such as families, youth, victims of domestic violence, seniors, persons who have been convicted of a crime, persons with a disability, persons who are chronically homleless, persons with HIV/AIDS, persons who are LGBTQ, veterans, persons with limited English proficiency, and persons who are undocumented by including these elements into the Coordinated Entry Queue data. The CoC also utilizes the data provided by the Longitudinal System Assessment. Once data is collected, to accurately assess CoC progress, reports are generated that allow for a thorough evaluation of service gaps by the Continuum of Care, its' committee members, and staff. Specific service providers that work with these special populations are engaged with to help identify any additional gaps in services and provide training to CoC organizations. These gaps are then prioritized as funding is identified.

Homelessness Response System Gaps Question 1e - Begin Answer Racial or ethnic disparities in the delivery of homeless services had not been prioritized until recently. The use of the LSA has assisted us in our ability to assess and identify these disparities. The intent is to ramp up efforts to assess these disparities in future community surveys and interviews with key informants. Currently we are using the data available through Stella tools to assess and inform the approach to these disparities. Homelessness Response System Gaps Question 1e - End Answer

Homelessness Response System Gaps Question 1f - Begin Answer Gap Assessments are conducted as needed. A ten year homeless strategy was created in 2014 and priorities updated with assistance from the Technical Assistance Collaborative in 2019. Due to capacity issues, the County was requested to support the Butte Countywide Continuum of Care by serving as the HMIS Lead Agency and Administrative Entity. The CoC's previous capacity for conducting gap assessments were limited to informal and formal discussion during monthly meetings, PIT and HIC analysis, and information shared among service providers in the Homeless Services Response System. Plans for another more formal gaps assessment are being made

and anticipated to be implemented post COVID-19 pandemic. Homelessness Response System Gaps Question 1f - End Answer

g. How findings are used to make informed decisions for funding projects within the community; and

Homelessness Response System Gaps Question 1g - Begin Answer The Butte Countywide Homeless CoC, in partnership with Butte County, holds a series of meetings to discuss funding, such as HHAP. Using the findings from the assessment, eligible spending categories are selected. This ensures that the gaps in services are addressed with funding that is available. Being a rural region, supplementing the funding necessary for the delivery of these identified needs is always a challenge.

Butte County staff from several County departments (Administration, Development Services, Employment and Social Services, Behavioral Health, and Public Health) collaborate and meet with representatives from the local jurisdictions, non-profits and other housing groups to identify local priorities using these findings to make informed decisions for funding projects within the community. Homelessness Response System Gaps Question 1g - End Answer

Homelessness Response System Gaps Question 1h - Begin Answer Butte County will use the data collected from approved HHAP-2 funded service providers and information available to us through LSA, PIT, HIC, Coordinated Entry, HMIS and other ongoing assessments to make sure we evaluate the impact of HHAP-2 funds during the 5 year grant period. Butte County will utilize the HUD system performance data as well as local outcomes submitted by HHAP sub-recipients to measure if identified program goals are being met.

Homelessness Response System Gaps Question 2a - Begin Answer Using the 2019 Point in Time information there are 891 persons experiencing homelessness in our jurisdiction. Approximately 56% are male, 43% are female and 1% are Transgender or gender non conforming. 74% are white, non-hispanic/non-latino. 9% White, Hispanic/Latino. 7% Black or African American. 1% Asian. 4% American Indian or Alaska/Native. 1% Native Hawaiian/Other Pacific Islander. 3% Multiple Races. 1% Unknown. Existing funding and programs which address homelessness within the jurisdiction include, but are not limited to: FEMA, CDBG, HEAP, ESG-CV1, ESG-CV2, HOME Investment, CalWorks HSP, COVID-19 Emergency Homeless Funding, HDAP, CDSS-COVID Emergency Funds, CESH 1, CESH 2, CERG, Bringing Families Home, Homesafe, CalWorks HSP, CalWorks Homeless Assistance, HHAP. Butte County manages the HMIS and Coordinated Entry System for the community. The attached Homelessness Response Local

Homelessness Response System Gaps Question 2b - Begin Answer Continuum of Care Outcomes by Race and Ethnicity, Stella 2018 data is used by our Continuum of Care along with information gathered from our PIT. Homelessness Response System Gaps Question 2d - Begin Answer During the operation of Project Roomkey, the need for longer term housing Case Management for newly housed individuals has been identified. This is a vital component to ensuring housing stability and self-sufficiency for newly housed individuals. No other disparities were found at this time, however currently through our efforts with Project Roomkey we are housing over 100 individuals in local hotels, and have successfully found permanent or transitional housing for 144 individuals. Retention rates are not yet known for this population.

2. Regional Resources Planning

When working within the homelessness system, it is critical to assess the current resources available within the community to ensure any new resources are most effectively and efficiently targeted to best serve people experiencing homelessness within the community. Given the high number of people experiencing homelessness in California and the unprecedented amount of federal and state funds available to address homelessness, HCFC expects applicants to coordinate all available funding to safely shelter and permanently house as many people experiencing homelessness in the applicant's community as possible, with a particular focus on rehousing individuals currently living in Project Roomkey (PRK) sites.

Regional Resources Planning Question 1 - Begin Answer The Continuum of Care, County, and all local partners meet on a monthly basis to address the needs of homelessness in our community. In order to coordinate all available local, state and federal funds we have representation on the CoC from all jurisdictions who bring forth the knowledge of available funding streams. As seen with the CoC redirecting their share of the HHAP-2 funding to the County, this is truly a regional approach for needs.

3. HHAP-2 Funding Plans

When planning how to target new HHAP-2 resources, it is essential to do so in direct response to the gaps assessment and current regional investment planning described in Sections 1 and 2. HHAP-2 Funding Plans Question 2 - Begin Answer

Currently the County operates Project Roomkey with over 100 FEMA Qualified individuals in Hotels. 144 persons have left for Permanent or Transitional Housing, and over 465 Total cumulative individuals have been served since the program began. Currently our Project Roomkey staff, providers and Case Managers meet weekly to discuss permanent housing pathways for these clients and there is a Housing Team put together which looks for potential options in our community which can be matched with each individual's unique needs, such as limited funding or poor credit.

Currently we are exploring Project Homekey funding which has been identified as a potential other resource to meet the need for households staying at Project Roomkey sites to not return to unsheltered locations or congregate settings.

HHAP-2 Funding Plans Question 3 - Begin Answer

Butte County, as the applicant jurisdiction, will be providing the grant administration for HHAP funded projects. The county intends to use a senior level anayst to provide the administrative duties required. The analyst leveraged will spend approximately 20% of their time, over the coure of the grant, to issue a Request For Proposal (RFP) using the county procurement process and tailored to match the priorities identified by the community, will award and issue contracts, monitor the projects, provide updates to the community during Continuum of Care Meetings and complete the reports associated with the grant.

The amount allocated from HHAP to be used for the grant administration does not cover the scale of support needed. The county will be providing the costs associated with management, supplies needed and overhead, including fiscal oversight as in-kind grant support.

HHAP-2 Funding Plans Question 4 - Begin Answer

The Continuum of Care has a youth specific committee which works with our CoC and services providers to leverage the adult system to serve youth. Area service providers, such as Youth for Change, which have historically taken the area's lead role in serving this population will be encouraged to apply for HHAP-2 funding which has been set aside to ensure that youth can access services. Ongoing monitoring by the Administrative Entity will be used to ensure that targeted spending meets these identified needs.

The Continuum of Care has representation from individuals on the Executive Committee and general membership, and has a specific committee for Chronic Homelessness with membership representing this demographic. Additionally, when assessments for gaps in services are made for funding planning, design, implementation, and evaluation, additional input is sought from individuals with lived experience from throughout the community.

The biggest barrier that we have seen in working with regional partners is usually jurisdictionally based, for example our primary Congregate Sheltering location is in the City of Chico, however that sometimes leads agencies serving the homeless populations in their area feeling they are not getting the same level of support/funding. A main strategy that has been used to address this barrier, is that anytime an issue like this is brought up, the issue is treated with respect and an invitation is extended to the partner agency to look at available funding sources and help provide input in how funding can be equitably allocated to meet their needs.
