1. Homelessness Response System Gaps Assessment

Homelessness Response System Gaps Question 1a - Begin Answer Lassen County has not yet conducted a detailed, formalized gap assessment of the local homelessness response system. Lassen County's 10 Year Plan to Address Homelessness and Point-in-Time Count Data were used to determine how to use HHAP-2 funds to best meet the community's current needs Lassen County's 10 Year Plan to Address Homelessness was developed by Housing Tools, a consulting firm, and the final draft was published in June of 2020. The plan is still in draft form as it has yet to be approved by Lassen County's Board of Supervisors. The plan identifies needs and feasible solutions to move individuals and families from being unhoused to becoming stably housed and to prevent homelessness wherever possible. Lassen County's 10 Year Plan to Address Homelessness uses Point in Time (PIT) Count data as the primary quantitative data source on homelessness in Lassen County, Lassen County's 2020 PIT Count

data is unofficial in that it was not reported to HUD.

Because of a miscommunication with the NorCal CoC, Lassen County held it's annual 2020 PIT Count on a different date than the other counties in the CoC. As a result, Lassen County's 2020 PIT Count numbers were not used in the CoC's official report to HUD. However, Lassen County's PIT Count met all other HUD requirements and the data collected is still useful in assessing gaps and determining needs on a local level.

Beyond the PIT Count, data collection related to housing and homelessness in Lassen County has been limited. Until recently, there has not been Lassen County staff or programs specifically dedicated to addressing homelessness.

In September of 2019, Lassen County Community Social Services, hired a Housing Program Coordinator and a Housing Grants Specialist. These staff members are currently working to apply for funding, implement programs and coordinate with other service providers in the community to build and formalize an effective homeless response system. All Lassen County Community Social Services housing programs are new and processes to assess the success and track data within these programs are still being developed.

At the beginning of 2020, Lassen County Community Social Services started using an HMIS system. However, not all programs/services within the homeless response system utilize HMIS at this time. The numbers outlined in the Service Gap Analysis Chart are directly from the 2020 PIT Count Data. As a result the numbers are representative of just a snapshot of the gaps, needs, and services provided on the date of the count (January 25, 2020). At this time, Lassen County has yet to complete a more complete gaps/needs assessment that addresses specifically the services/needs outlined in this chart over a broader timeline. Additionally, there is not currently a process in place to capture the number of individuals who need prevention/diversion services, and as a result, these numbers were reported to be zero (although this is not the case). As Lassen County Community Social Services further develops it's homeless response system, a better system for tracking data that documents needs and services will be developed. This will include better use of the HMIS system and implementation of a Coordinated Entry System. There will be better processes in place to capture both the number of individuals needing a particular intervention as well as the number of individuals receiving those interventions. Technical assistance from the state in conducting a formal gaps/needs assessment and support in better tracking services/needs would be beneficial.

For the purpose of determining how to best spend HHAP-2 funds, Lassen County Community Social Services used the quantitative

data obtained from the PIT Count and qualitative information from Lassen County's 10 Year Plan to Address Homelessness.

 b. How people with lived experience of homelessness had ongoing meaningful and purposeful opportunities to participate in and inform the most recent gaps assessment and how they have meaningful opportunities to inform all levels of system planning over time;

Homelessness Response System Gaps Question 1b - Begin Answer The development of Lassen County's 10 Year Plan to Address Homelessness included directly consulting with people with lived experience of homelessness. Housing Tools conducted an in-person focus group and individual interviews of people with lived experience. Approximately twenty people engaged in the process. During the focus group and interviews, the individuals participating were given the opportunity to share about the primary causes of their homelessness, the specific resources and services they believed will be helpful for them, and what they felt people should know about the unique challenges of living un-housed in Lassen County.

In November of 2020, Lassen County established an Advisory Board to the NorCal Continuum of Care (the Board). The vision of the Board is to have a homeless response system that uses resources effectively, and quickly connects those in need with services to regain and retain housing or to prevent homelessness from occurring. The Board will play a primary role in system planning, and it is the goal of the Board to include people with lived experience of homelessness so that their voices impact and inform all levels of system planning.

c. Homelessness Response System Gaps Question 1c - Begin Answer Lassen County is home to the Susanville Indian Rancheria (SIR). SIR is a federally recognized rancheria of Native Americans and is made up of the Washoe, Achomawi, Mountain Maidu, Northern Paiute, and Atsugewi tribes. Although, SIR was not actively involved in the creation of Lassen County's 10 Year Plan to End Homelessness, the

Lassen County Advisory Board to the NorCal CoC (the Board) has invited SIR to participate in the Board and to play an active role in system planning. Other than SIR, there are not any organizations within Lassen County that have historically just served communities of color.

Homelessness Response System Gaps Question 1e - Begin Answer Racal and ethnic disparities were assessed by comparing data from the 2020 PIT Count to data from the 2019 Census Bureau estimate. In assessing this data, it was taken into account that Lassen County is home to two state prisons. The prison populations and demographics of those populations can skew the data. Because of

this, for the purpose of assessing racial and ethnic disparities, the prison populations were not included in the assessment.

Homelessness Response System Gaps Question 1f - Begin Answer Gaps and needs assessments related to homelessness and housing have not been regularly conducted in Lassen County. However, moving forward Lassen County's 10 Year Plan to Address Homelessness will be reviewed on an annual basis by the Lassen County Advisory Board to the NorCal CoC. Additionally, Lassen County Community Social Services is open to recommendations and technical assistance from the state regarding other regularly needed gaps/needs assessments.

Homelessness Response System Gaps Question 1g - Begin Answer Any findings made during the annual assessment of Lassen County's 10 Year Plan to Address Homelessness will direct decision making related to current and future funding projects within the community. Funding will be strategically used to fill gaps and address ongoing needs.

Homelessness Response System Gaps Question 2a - Begin Answer Data from 2020 PIT Count showed 121 individuals experiencing homelessness in Lassen County. Of these individuals:

- 72 individuals were sheltered, 49 were unsheltered
- 64 identified as male, 57 identified as female
- The majority (72 individuals) of those experiencing homelessness were in the 25-62 years old age range
- 57 individuals were chronically homeless
- 52 individuals reported this being the first time they've experiencing homelessness
- 36 individuals reported that a disability has prevented them from obtaining/maintaining stable housing
- 5 individuals reported that having a felony has prevented them from obtaining/maintaining stable housing
- 22 individuals reported having spent time in foster care
- 35 individuals reported growing up in Lassen and 40 individuals reported having family in the county Existing organizations which address homelessness within the jurisdiction include:

Homelessness Response System Gaps Question 2b - Begin Answer Data from the 2020 PIT Count showed that of the 121 individuals surveyed:

- 8 individuals reported being a veteran
- 32% reported living with a mental health condition
- 20% reported they had previously been in foster care
- 15% of those who reported their domestic violence status reported fleeing an abusive environment

The following gaps and needs regarding special populations were identified during the process of developing Lassen County's 10 Year Plan to address homelessness:

- There are no supportive housing units for those with special needs
- Housing and shelter options for those stuck between jail discharge and sentencing, with support services are limited
- There are high percentage of individuals with felonies and other convictions that bar them from federally-assisted housing.

- The Domestic Violence shelter runs a crisis call line but their staff can't address behavioral health issues
- The community doesn't have enough skilled people to provide mental health services
- Services for special populations may not be accepted in the neighborhood or community there is great stigma around homelessness.
- There are limited shelter options for some target populations, such as seniors with limited income, those with serious ongoing health needs, the very mentally ill who need supportive sheltering, and people with animals
- There is great community stigma and lack of understanding regarding mental health and substance use disorder challenges
- Detox services are out of county/state, away from local supports so people are hesitant to use them

Homelessness Response System Gaps Question 2b - End Answer

c. Data and qualitative information showing any racial or ethnic disparities in access to services, delivery of services and housing placement and housing retention outcomes of homeless services;

Homelessness Response System Gaps Question 2c - Begin Answer The 121 individuals surveyed in the 2020 PIT Count reported the following races:

- White Only: 76.03%
- Black or African American Only: 0.00%
- American Indian or Alaskan Native Only: 0.83%
- Asian Only: 0.00%
- Native Hawaiian or Pacific Islander Only: 9.09%
- Other Race Only: 0.00%
- Two or More Races: 14.05%

In comparison, the 2019 Census Bureau Estimate show the following percentages (these percentages do not include the block group that contains the two state prisons):

- White Only: 86.44%
- Black or African American Only: 3.27%
- American Indian or Alaskan Native Only: 3.21%
- Asian Only: 1.10%
- Native Hawaiian or Pacific Islander Only: 1.04%
- Other Race Only: 1.89%
- Two or More Races: 3.06%

This data does show disparities in regards to the percentages of Native Hawaiian or Pacific Islander who are homeless and the percentages of individuals reporting two races. One important factor to note when assessing data in a small community is that the numbers of even one large family can skew the percentages.

Another factor to note is that the disparity identified regarding households with two or more races, does not break down which races are being identified. It would be helpful to be able to identify which races are being represented in order to better identify where the disparities occur.

As shown in the Racial Demographic Data Upload, data from Stella, HUD's LSA Strategy and Analysis Tool, shows that people of multiple races spend more time homeless and have a lower rate of accessing housing. However, this data is for the NorCal CoC as a whole and is not specific to Lassen County. This is problematic as the counties within the NorCal CoC are very different. Additionally, the data available through this tool and through HMIS are limited in that not all of the programs and services provided within the homeless response system are currently tracked through those systems.

Lassen County Community Social Services would benefit from assistance in completing an assessment that pulls together data accurately from a variety of sources to better be able to analyze disparities within the homeless response system.

Homelessness Response System Gaps Question 2c - End Answer

d. Any other disparities that were found in the delivery of homelessness services including rates of successful permanent housing placements, and housing retention rates;

Homelessness Response System Gaps Question 2d - Begin Answer In Lassen County's 10 Year Plan to Address Homelessness it was reported that the Lassen County Behavioral Health Department conducts weekly outreach at the Crossroads Emergency Shelter, and the County has newly dedicated housing staff who conduct outreach to those experiencing homelessness on the street and who are camping around city limits. However, since the writing of the Plan, outreach has been significantly limited. This is in part due to the ongoing pandemic, but also because the county's housing staff positions are grant funded, and there are no grants currently dedicated to outreach.

Furthermore, the Plan identifies the following challenges related to services/outreach:

- Engaging individuals experiencing chronic homelessness has been difficult
- Trust is often broken with homeless clients. Despite best efforts they often don't see solutions or results. This results in too much bouncing around from service provider to service provider.

 Another glaring gap that both the Plan and the data show is that there is a shortage of affordable housing and no permanent supportive housing with services. The lack of permanent supportive

housing limits successful housing placement rates. While this is an identified need, Lassen County does have funding to address this need. A barrier, however, has been not having the needed community support to develop permanent supportive housing. Homelessness Response System Gaps Question 2d - End Answer

Regional Resources Planning Question 1 - Begin Answer
One of the roles of the newly formed Lassen County Advisory Board (the Board) to the NorCal CoC will be to coordinate local, state and federal funds and resources that address homelessness in Lassen County. Prior to the development of the Board, there was not a formal process in place to coordinate all funds and resources.

Lassen County Community Social Services does internally assess and monitor existing funding and when applying for new funds assesses where gaps in funding exist. Currently, as the Homelessness Response Local

Investment Plan shows, there are county funds for: Non-Congregate

Shelter, Rental Assistance, Permanent Supportive Housing, and Homeless Prevention.

3. HHAP-2 Funding Plans

When planning how to target new HHAP-2 resources, it is essential to do so in direct response to the gaps assessment and current regional investment planning described in Sections 1 and 2. The Lassen County Community Social Service staff who will implement the HHAP-2 projects will conduct targeted outreach to youth, including outreach at local middle schools, high schools and at the local community college. Staff have already developed connections at Lassen High School, the high school in Susanville (Lassen County's largest community). However this relationship can be strengthened and additional relationships need to be built with the schools in the outlying areas of the county. Additionally, staff from the housing team will participate in Lassen County's Children's System of Care, in order to ensure that transitional aged youth who are experiencing homelessness and are within the Children's System of Care have the opportunity to engage in and access needed housing services.

Lassen County Community Social Services' overall goal for the HHAP funds is to increase connections and engagement with individuals experiencing homelessness in Lassen County, particularly individuals who are chronically homeless, are mistrustful of the system, and have had limited participation with the homelessness response system in the past. Better engagement with service providers will lead to better permanent housing outcomes. Progress and success of this goal will be evaluated by tracking the length of engagement with service providers as well as the number of those individuals who obtain permanent housing.

Lassen County's HHAP-1 project is a Rapid Re-Housing Program. The program's goal is to assist families and individuals experiencing homelessness obtain permanent housing. The program has three components: Housing Identification, Rent and Move-In Assistance, and Case Management. The HHAP-1 goals were to:

- Serve 30 individuals
- Place 65% of those individuals in permanent housing
- Assist 10 households in obtaining permanent housing. Of these 10 households a minimum of two will be homeless youth.
- Build connections with 3 landlords who are willing to rent to families or individuals experiencing homelessness.

The systemwide goal of HHAP-2 is to increase connections and engagement with individuals experiencing homelessness in our community, particularly individuals who are chronically homeless, are mistrustful of the system, and have had limited participation in with the homelessness response system in the past. Whereas the goal of HHAP-1 is to implement permanent housing, the goal of HHAP-2 is to better reach individuals who have been more difficult to engage with but are often the highest need individuals so that these individuals have equal opportunity

to secure permanent housing and are successful in maintaining permanent housing.

The 2020 Data did not include any youth data. This is because the youth who are experiencing homelessness are often less visible or do not meet the definition of homelessness used for the PIT Count.

Because youth homelessness is often less visible, outreach needs to be conducted differently. Lassen County Community Social Services youth-specific goal is to develop a youth specific outreach campaign. Outreach will include engaging with the child welfare system, juvenile probation, all of the middle schools and high schools in Lassen County and the local college.

Additionally, Lassen County's 10 Year Plan to Address Homelessness, which has been created to guide the housing and homeless response system in Lassen County, will be reviewed by the Board on an annual basis. During this review process needs, gaps, goals, and existing services will be assessed in order to ensure that the system is as effective as possible.

There is an intervention identified under Priority Area 3 of the Plan: Multidisciplinary Approach to Outreach and Crisis Intervention. Part of the goals of this priority area is to proactively engage unsheltered individuals and families. The proposed goal for HHAP-2 funds is to better engage with individuals who are underserved.

One of the primary ways that the priority populations learn about and enter local homelessness programs is via word of mouth. Often if one individual has a positive experience receiving a needed service, they will pass information about the program or service along to other individuals in need. One strategy used currently, and that will be continued to use as outreach is expanded, is to ask individuals being served if they know of others in need and then provide business cards and/or marketing materials to individuals to pass along to their acquaintances, friends and families.

Another strategy that is used by Lassen County Community Social Services is to maintain regular communication with community partners about programs and services available. For example, if a an individual in need is picking up food at a local food pantry, that person could also receive information about housing services at the same time.

Lassen County Community Social Services is also engaging with the NorCal CoC to develop a Coordinated Entry System. The goal is that this system will improve equitable access to the local homelessness programs.

Finally, it is the goal of the proposed HHAP-2 project to increase outreach and engagement to priority populations in order to improve access to and success within the homelessness programs in the community.

Regional Collaboration and Partnerships Question 1 - Begin Answer Lassen County is a member of the NorCal Continuum of Care (CoC). The NorCal CoC includes seven counties in the Northern California. Four of these counties share borders with Lassen County. [The CoC has an Executive Board. The Executive Board is the decision-making body for the CoC. Members of the Executive Board include local officials, service provider agencies, formerly homeless individuals, and advocates. The Executive Board is comprised of seven voting members, one from each of the counties in the NorCal CoC region. This ensures fair distribution of appointment across organizational affiliations and representation of all relevant homeless subpopulations.]

[The CoC Executive Board has a Lead Agency, Shasta County Community Action Agency, that provides guidance to ensure that duties of the CoC are being met. Additionally, each county within the CoC has a local Advisory Board that includes representatives from relevant stakeholders in each county region.

Lassen County's Advisory Board meets monthly (or as needed) to collaborate, share information, and to make local level decisions. Lassen County's Executive Board member then communicates and shares information from the local Advisory Board at the CoC's Executive Board meetings. This allows for collaboration and coordination on a local level (through the Advisory Board) and between all the counties within the CoC (through the Executive Board)]

The Executive Board meets monthly and members work together to create solutions to address homelessness for the communities within the NorCal CoC. The monthly meetings include discussions about funding and counties have the opportunity to share updates, successes, and challenges.

The counties within the CoC share data by using a shared HMIS provider.

Additionally, the NorCal CoC is currently developing a Coordinated Entry

System in which all CoC counties will participate.

[The CoC actively pursues funding and manages that funding, distributing it between the counties that make up the CoC. Once funding is received by the CoC, it is distributed between the seven counties by a competitive open application process or by an allocation method determined by regional need based on each county's PIT Count numbers.]

Because Lassen County communities are separated by significant distance from the other communities within the CoC, it is sometimes difficult to share resources. Lassen County does however share some resources with bordering counties within the CoC. For example, the Plumas County Community Development Commission and Housing Authority runs a Section 8 Housing Choice Voucher Rental Assistance Program for multiple counties, including Lassen County.

Regional Collaboration and Partnerships Question 1 - End Answer

Regional Collaboration and Partnerships Question 2 - Begin Answer Lassen County is a member of the NorCal Coc. Other counties within the CoC region also receive HCFC funding. However, because the communities within the CoC counties are separated by significant distance from the other communities, the services within the different jurisdictions do not overlap. Within the Lassen County specific region, there are currently no other partners that also receive HCFC funding.

For example, Lassen County Community Social Services has had an existing relationship with Crossroad Ministries. Crossroads Ministries provides emergency shelter, transitional housing and a number of other services to individuals

experiencing homelessness within Lassen County. Through the implementation of new funding sources, including HHAP-1, staff from Lassen County Community Social Services have built on the existing relationship with Crossroads Ministries. Referrals are regularly made between the two organizations and funding and services are often combined to best serve individuals in need. No specific barriers to working with regional partners have been identified.

Regional Collaboration and Partnerships Question 5 - Begin Answer Lassen County is defined as a small county in regards to population but is a large, geographically. Lassen County covers an area that is approximately the size of the state of Connecticut. Lassen County is separated by significant distance from communities in other counties within the NorCal Coc. The nearest metropolitan area, within the CoC, is Redding in Shasta County. Redding is a two hour drive through the mountains from Susanville (the largest community within Lassen County).

Additionally, Lassen County does not share jurisdiction with any "Large City." Therefore, Lassen County's identified share of the regional need is the residents of Lassen County. With the requested funds, Lassen County Community Social Services will conduct outreach and provide services that promote engagement to families and individuals experiencing homelessness within Lassen County.

[When funding is made available to the CoC, one of two methods is used to determine funding allocations. The first method is a NOFA process, which

includes an open application process across the CoC region and the use of a rating and ranking committee when funds are oversubscribed. The rating and ranking committees are committees of neutral groups of three or more individuals who rate and rank funding applications based on the rating and ranking policies and procedures. The second method is an allocation method, which includes a formula based on the first 80% of the available funding distributed using the most recent HUD approved Point In Time Count and the remaining 20% using the most recent executed contract with the county to provide financial support for the CoC's Lead Agency. This methodology is also used by the CoC when funds are oversubscribed. In the case of a particular county being oversubscribed, a rating and ranking committee formed locally is used, which is formed by the local Advisory Boards.]

Regional Collaboration and Partnerships Question 5 - End Answer

6. Describe how HHAP-2 funds will be integrated into the current regional strategic plan to address homelessness. Has the region's strategy for use of HHAP funding changed since HHAP-1?

Regional Collaboration and Partnerships Question 6 - Begin Answer The region's strategic plan to address homelessness has not changed since HHAP-1. Lassen County's 10 Year Plan to Address Homelessness (Plan) identified the following service and outreach challenge: Staff conducting outreach report that finding and reaching the population is not difficult, but engaging them in services has generally been challenging. Additionally, the amount of outreach that was described in the Plan has decreased since the writing of the report. This is in part due to the ongoing pandemic, but also because the housing staff referred to in the Plan are in grant funded positions and there are currently no grants that fund outreach. Lassen County Community Social Services is proposing that HHAP-2 funds will be used to conduct outreach and provide services that improve engagement outcomes. Increased outreach and engagement services will ensure that the available services, such as rapid re-housing services, are more accessible, available and targeted to the highest need individuals and families in the community. Improved engagement to the highest need individuals and families will ensure that those with the highest need are obtaining permanent housing.

One step to address this could be to develop a youth specific strategy that will be incorporated into Lassen County's 10 Year Plan to Address Homelessness.

Lassen County Family Solutions is a division of Lassen County Community Social Services that provides wraparound services to children and youth in Lassen County. The Board will continue to seek out and recruit other youth-specific local partners to be members of the Board. As members of the board, these partners will be able to be actively involved in regional planning and spending decisions.
