Requirements

 Per 2023 NOFA, Pursuant to 24 CFR Part 5, all CDBG Applicants are required to verify they and their principals, or any/all persons, contractors, consultants, businesses, subrecipients, etc., that are conducting business with the Applicant are not presently debarred, proposed for debarment, suspended, declared ineligible, or voluntarily excluded from participation in the covered transaction or in any proposal submitted in connection with the covered transaction.



Requirements

(Continued)


- All Applicants and Applicant Partners must not be debarred, suspended, proposed for debarment, declared ineligible, voluntarily excluded from participation, and/or unregistered in SAM.gov from federally assisted programs.
- Sam.gov provides verification of debarment. This is intended to prevent waste, fraud and abuse in Federal procurement and non-procurement actions.




Documentation for NOFA

- Submittal of an incomplete or incorrect debarment check will no longer disqualify an Applicant. The department will work with the applicant to ensure correct submittal of debarment checks.
- Please note verification must be done prior to funds being awarded.
- Documentation should include a full print out from Sam.gov.






















