

## In reference to the requirement of a Mayor to be the authorized signer, are you saying that a resolution designating another person is no longer sufficient?

Pursuant to California Government Code sections 40601 and 40602 the Authorized Signatory for cities must be the mayor or mayor pro tempore unless there is an ordinance, municipal code, or city charter provision in effect that specifically allows or designates contracts to be signed by another person.

HCD will revise the Governing Body Resolution to include language that distinguishes an Authorized Signatory for contracts, and an Authorized Designee position identified by resolution from the City Council, which allows a position other than the mayor or mayor pro tempore to submit Financial Reports, Activity Reports, Reimbursement requests, NEPA documents, and other required submissions that are not contracts.

This does not apply to counties.

#### When It comes to the resolution for the application - can there be a city Reso and the state reso?

If a jurisdiction must prepare a concurrent resolution that conforms to local standards it may do so, but an approved resolution on the Department-approved form must be included in the application

Do we know when the CDBG-CV 2&3 remaining funds awardees will be announced? We received a notice that applications had been received June 5th, and it would take three weeks for review. Is that review period the submission of April 15th or June 5th?

ICF grant administrators will reach out to you with an update on your request, provided that all documentation is sufficient. The timeline for review methodology is Tribal and Homekey first. CV2 and 3 will be last to be processed. Hopefully in the next couple of weeks you will hear from ICF.
