Signer”) to enter into, execute and deliver any and all agreements deemed necessary or appropriate by the Department, including but not limited to the Department’s Standard Agreement and any amendments thereto, and any and all other documents necessary or appropriate to evidence or secure the funding to be received by Applicant, and any and all subsequent amendments thereto (collectively, the ”Award Documents”).

SECTION 5:

If an application is approved, the Governing Body hereby authorizes and directs the Enter Designated Official Title (the “Funds Request Singer”), or Designee Enter Designated Official Title (the “Funds Request Designated Signer”) to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.

** **Important Note:** If Governing Body adds additional limitations or conditions on the authority of any signer above, this will result in this Authorizing Resolution being rejected and will require your entity to issue a corrected Authorizing Resolution prior to the Department issuing a Standard Agreement. The only exception is for county counsel to approve as to form, or legality or both, and IF such approval is already part of the standard county signature block as evidenced by the signed Resolution itself.*
