SECTION 1:

The Governing Body has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$0.00 , as it relates to any CDBG-DR 2023/2024 CDBG-DR Infrastructure (DR-INF) & Mitigation Resilient Infrastructure & Planning Program (MIT-RIPP) award issued from the California Department of Housing and Community Development (the "Department").

SECTION 2:

SECTION 3:

Enter Designated Official Title (the "Application Designated Singer") to execute and deliver all applications and act on the Applicant's behalf in matters pertaining to all such applications.

SECTION 4:

If an application is approved, the Governing Body hereby authorizes and directs the Enter Designated Official Title (the "Standard Agreement Authorized Signer"), or Designee, Enter Designated Official Title (the "Standard Agreement Designated

Signer") to enter into, execute and deliver any and all agreements deemed necessary or appropriate by the Department, including but not limited to the Department's Standard Agreement and any amendments thereto, and any and all other documents necessary or appropriate to evidence or secure the funding to be received by Applicant, and any and all subsequent amendments thereto (collectively, the "Award Documents").

SECTION 5:

If an application is approved, the Governing Body hereby authorizes and directs the Enter Designated Official Title (the "Funds Request Singer"),or Designee Enter Designated Official Title (the "Funds Request Designated Signer") to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant.

* Important Note: If Governing Body adds additional limitations or conditions on the authority of any signer above, this will result in this Authorizing Resolution being rejected and will require your entity to issue a corrected Authorizing Resolution prior to the Department issuing a Standard Agreement. The only exception is for county counsel to approve as to form, or legality or both, and IF such approval is already part of the standard county signature block as evidenced by the signed Resolution itself.
