I. Background and Summary of Changes

On January 6, 2021, the U.S. Department of Housing and Urban Development (HUD) released Federal Register Notice 86 FR 561 that allocated an additional \$64,907,000 of Community Development Block Grant Mitigation (CDBG-MIT) funds under Public Law 116-20 for the State of California. The additional funds are to support mitigation efforts in areas impacted by FEMA Disasters DR-4382 and DR-4407, covering Butte, Los Angeles, Ventura, Lake, and Shasta Counties, with no less than 50 percent of the funds expended in the most impacted distressed areas (MIDs).

HCD received approval for its prior 2017 CDBG-MIT Action Plan on June 4, 2020. The January 2021 Federal Register Notice states that grantees that have previously received CDBG-MIT allocations are able to amend their original Action Plan to create a single CDBG-MIT Action Plan covering both 2017 and 2018 disasters through a Substantial Action Plan Amendment.

HCD's substantial action amendment 2017 and 2018 CDBG-MIT Action Plan (MIT APA1) was submitted and approved by HUD in July of 2021. The 2017 and 2018 CDBG-MIT Action Plan Amendment two (MIT APA2) was submitted and approved by HUD in May of 2023. There were two subsequent non-substantial amendments done in December of 2023 and December of 2024.

The 2017 and 2018 CDBG-MIT Action Plan Amendment Five (MIT APA5) is a non-substantial amendment that moves unused funding from the Planning and Public Services Programs to the Resilient Infrastructure Program. This amendment will also change the current \$3 million threshold for substantial amendments to \$10 million.

Page numbers are provided with the proposed changes. Removed and replaced text updates have been made in the context of the named section within the action plan.

Summary of Changes:

Action Plan Amendment 5 (APA 5) will address changes in the following items:

- Resilient Infrastructure Program: Edits in this section is made to move the unused Planning and Public Services Program budget to address outstanding unmet need in the Resilient Infrastructure Program and adjust budget for local assistance amount.
- **Substantial Amendment:** Edits in this section provide an update on the threshold increase for substantial amendment from \$3 million to \$10 million.

II. Action Plan Amendments

The summary table shows the change in the budget that reallocates funds from the 2017 Planning and Public Services budgets to the 2017 Resilient Infrastructure Program. Additionally, budget adjustments were done to reflect the correct local assistance amounts.

A. Substantial Amendment (Page 92)

Local assistance awards include the activity delivery costs incurred by the local governments as well as project costs.

Resilient Infrastructure Program

a) Program Description

Remove:

This program provides local jurisdictions with an expansive and hands-on role in driving local community infrastructure needs that meet the definition of mitigation activities. The Resilient Infrastructure Program allocated \$61,379,000 of CDBG-MIT funding to assist local jurisdictions with mitigation-related infrastructure needs to support risk reduction from the three primary hazards (wildfire, flooding, and earthquake) as established within the updated 2017 Mitigation Needs Assessment. The additional release of 2018 CDBG-MIT funds will bring the total Resilient Infrastructure Program allocation to \$106,554,272.

Replace:

This program provides local jurisdictions with an expansive and hands-on role in driving local community infrastructure needs that meet the definition of mitigation activities. The Resilient Infrastructure Program allocated CDBG-MIT funding to assist local jurisdictions with mitigation-related infrastructure needs to support risk reduction from the three primary hazards (wildfire, flooding, and earthquake) as established within the updated 2017 Mitigation Needs Assessment. The additional release of 2018 CDBG-MIT funds bring the total Resilient Infrastructure Program allocation to \$108,178,940.

a) Program Description

Remove:

HCD allocated \$20,779,050 of 2017 CDBG-MIT funding to the Resilience Planning and Public Services program to address these needs. HCD allocated an additional \$12,286,378 of 2018 CDBG-MIT funding to the Resilient Planning and Public Services Program, for a total of \$33,065,428.

Replace:

HCD allocated \$19,803,268 of 2017 CDBG-MIT funding to the Resilience Planning and Public Services program to address these needs. HCD will allocate an additional \$11,637,492 of 2018 CDBG-MIT funding to the Resilient Planning and Public Services Program, for a total of \$31,440,760.
