MIT Infrastructure Resilience: All seven of the Mitigation Resilient Infrastructure Program (MIT-RIP) subrecipients have fully executed master standard agreements. Thirteen project applications have been recommended for award, all necessary due diligence items have been submitted, and HCD is working with the subrecipients to move the projects towards Notice to Proceed. HCD has hosted ten environmental kick-off meetings, one project has completed the environmental review process and been issued the authority to use grant funds. HCD has designed program implementation resources for staff and begun a training series to orient staff to the available resources and standard operating procedures.

MIT Pling and Capacity Building: HCD distributed award letters to subrecipients and legislative letters to representatives. Thirteen subrecipients received letters for a combined total of 21 planning projects. Applicants had 60-days to complete outstanding due diligence items that were identified in their award letters. HCD maintained weekly or bi-weekly communications with subrecipients to remind and support subrecipients in completing their outstanding items. HCD finalized the standard agreement templates and updated its standard operation procedures on preparing and packaging the agreement. HCD drafted standard agreements for all projects and submitted to route, internally, for review and approval. HCD designed program implementation resources for staff and began a training series to orient staff to the available resources and standard operating procedures.

MIT Public Services: HCD distributed award letters to subrecipients and legislative letters to representatives. Nine
