These notices satisfy two separate but related procedural requirements for activities to be undertaken by the California Department of Housing and Community Development (HCD: Responsible Entity) and the Yurok Indian Housing Authority.

NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

On or about January 13, 2026, the California Department of Housing and Community Development (HCD) will submit a request to the Department of Housing and Urban Development (HUD) for the release of HOME American Rescue Plan (HOME-ARP) Program funds under Section 3205 of the American Rescue Plan Act of 2021, to undertake a project known as the Yurok Klamath Townsite – Home Replacement Project. Proposed funding includes approximately \$4,506,848 from the HOME-ARP Program. The Klamath Townsite Home Replacement Project is a redevelopment project within an established residential subdivision along Salmon Ave.. The project will take place on 13 lots, 11 of which are currently occupied single-family residences with detached garages and two vacant lots. The existing structures will be demolished, including garages and foundations. All 13 lots will be redeveloped into new single-story residences on concrete slab foundations. Existing utility hookups will be used. This redevelopment project is designed to improve housing conditions while leveraging existing infrastructure and minimizing environmental disruption. The project would be developed on approximately 2.285 acres of the Yurok Tribal Indian Reservation Land in Klamath, Del Norte County, California.

FINDING OF NO SIGNIFICANT IMPACT

HCD has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at HCD at 651 Bannon St. Sacramento, CA 95811 and may be examined or copied Monday through Friday 9 AM to 4:30 PM. PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to HCD, Attn: Jason Bradley, DFFA Branch Manager, HCD, 651 Bannon Street, Sacramento CA, 95811, or by email to NEPAComments@hcd.ca.gov. All comments received by January 12, 2026, will be considered by HCD prior to authorizing submission of a request for release of funds. Comments

should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

HCD certifies to HUD that Jason Bradley, in his position as DFFA Branch Manager of HCD, in his capacity as Certifying Officer, consents to accept the jurisdiction of the federal courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies their responsibilities under NEPA and related laws and authorities and allows HCD to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of HOME-ARP funds and to HCD's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on the following bases: (a) the certification was not executed by the Certifying Officer of HCD; (b) HCD has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (e) another federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted to HUD Region IX in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Leticia Johnson, Community Planning and Development Director, HUD San Francisco Regional Office, One Sansome Street, Suite 1200, San Francisco, CA 94104 or if by email to HUD Region IX, at RROFSFRO@hud.gov. Potential objectors should contact HUD via email at RROFSFRO@hud.gov to verify the actual last day of the objection period.
