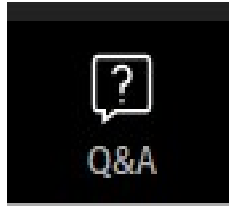

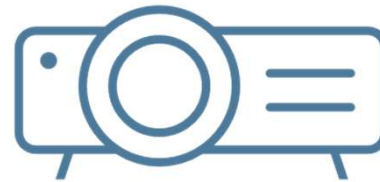

STANDARD AGREEMENT AMENDMENT PROCESS

- Standard Agreements (Contracts)
- Prior to 2024 - One-Year Standard Agreements
- 2024 – ESG Moved to Multi-Year Standard Agreements
- One Standard Agreement (i.e. 24-ESG-12345) with multiple years of funding
 - FY24, FY25, FY26



STANDARD AGREEMENT AMENDMENT PROCESS

Amendments are in process

- Adding 2025 Funding
- Updating Budgets
- Changes can be made at a later date
- RFFs can not be submitted in eCivis while the Amendment is processing



STANDARD AGREEMENT AMENDMENT PROCESS

2024 ESG Funds

- Spend down Remaining Funds
- Expenditure Deadlines
- Submit your Final RFF
- Certificate of Completion
- Annual Reporting Process



STANDARD AGREEMENT AMENDMENT PROCESS

2025 ESG Funds

- Start Planning Year 2 Spending Goals.
- Meet with Providers to develop a Spending Plan.
- Review 2025 Expenditure Deadlines.
- Begin deploying FY25 ESG Funds in your Community.



STANDARD AGREEMENT AMENDMENT PROCESS

Helpful Reminders

- Contract number will remain the same.
- Overlapping Contract Years.
- FY25 RFF numbering will continue where FY24 left off.
- FY24 ended with RFF #3 / FY24 begins with RFF#4.
