Quick Overview


- \$30 million total funding pot → \$1M-\$10M grants available on a competitive basis (funded under AB 140)
- Eligible Applicants = Metropolitan Planning Organizations (MPOs), Councils of Governments (COGs), local governments, transit agencies, Tribal Entities, and other eligible entities (through legally-binding partnerships)
- The HIT allocation is intended to support innovative, place-based approaches in Disadvantaged and Historically Underserved Communities that are scalable and further REAP 2.0's goals and objectives
 - REAP 2.0 Program Objectives = <u>Transformative Projects</u> that:
 - Support infill housing production and affordability goals
 - Affirmatively Furthering Fair Housing (invest resources equitably)
 - Reduce Vehicle Miles Traveled (VMT)
- Apply by December 31, 2022



Background

- California Comeback Plan: \$600M of new funding to support housing and climate projects across the state → REAP 2.0
 - Recognition that the state is not on track to meet it's housing and climate goals
 - Inspired by the success of REAP 1.0
 - 3 REAP 2.0 Allocations: HIT (\$30M), MPO (\$510M), Tribal & Rural (\$30),
 - HIT allocation rationale: competitive allocation that rewards eligible entities for exceptional model projects

The REAP 2.0 Trio: Differences & Funding Breakdown



- MPO: over-the-counter allocations based on population (\$510m)
- Tribal & Rural Non-MPO Counties: Competitive Set-aside (\$30m)
- 3. Competitive Higher Impact Transformative (\$30m)
 - 1. Flexible eligibility list. Eligible applicants of 1 & 2 are also eligible to apply for HIT

***State Program Admin (\$30m)







Outreach

- Outreach to date:
 - November 2021: Framework Paper & Survey with initial concepts and survey for broad stakeholder input
 - September 2022: 3-week public comment period for HIT Draft Guidelines closed September 29th
- Input received:
 - Lower the minimum and maximum award amounts to provide more opportunities to a greater number of applicants
 - Increase points available in the scoring criteria for scalability/transferability
 - Clarify language such as who is eligible and what we mean by place based \checkmark
 - Extend legally binding agreement submission deadline to March 31, 2023
 - The December 31, 2022 application deadline is challenging \times
 - Note: we cannot change a statutory deadline

Program Overview

- Grant program that funds both planning & implementation activities
- Eligible Applicants = Metropolitan Planning Organizations (MPOs), Councils of Governments (COGs), local governments, transit agencies, Tribal Entities, and other eligible entities (through legally-binding partnerships)
- Suballocations are not permitted ×
- Emphasis on Transformative + Place-Based strategies that benefit disadvantaged and historically underserved communities

REAP 2.0

Program Objectives & Nexus Requirement

Each application <u>must</u> propose uses that demonstrate a significant beneficial impact and a nexus to furthering REAP 2.0 Program Objectives:

Accelerating Infill Development







Affirmatively Furthering + Fair Housing



Threshold Requirements


- Threshold Requirement 1: must demonstrate how each proposed use directly benefits and is located within Disadvantaged and Historically underserved communities.
- Threshold Requirement 2: must demonstrate a commitment to place-based strategies that encourage community revitalization
- Threshold Requirement 3: proposed uses must lead to substantial changes for each of the 3 program objectives compared to a baseline.

Eligible Uses



Eligible vs Proposed Uses

- Eligible Use (EU): any activity that <u>either</u> further all REAP 2.0's objectives <u>OR</u> in combination with other eligible uses within a proposed use, fulfill all three objectives.
 - Flexibility provided—examples of eligible uses on next slide and in guidelines
- Proposed Use: a program or "umbrella" of eligible use(s) that:
 - Demonstrate a reasonable relationship to each other
 - Together fulfill REAP 2.0 objectives





Eligible Uses

• 4 categories with <u>examples</u> below:

- Accelerating infill housing development
 - Affordable housing development
 - Rezoning / reducing permitting barriers
 - Place-based infrastructure investments
- Realizing multimodal communities
 - Bike + Ped planning or implementation
 - Vision Zero / safety plans
- Shifting travel behavior by reducing driving
 - Roadway/parking pricing programs
 - Transit-oriented development
- Increasing transit ridership
 - Integrating transit systems / seamless transfer
 - Multimodal access to transit facilities
- Applicants may propose their own eligible uses that further REAP 2.0 Objectives in consultation with REAP 2.0 Interagency Partners

- Selected applications will receive an Award Letter from the Department and will enter into a state Standard Agreement to be awarded funds.

In order to be eligible for grant funding, applicants must submit an application by email to: <u>REAP2021@hcd.ca.gov</u>. For the (1) MPO Direct Allocation, applications will be accepted on an Over-The-Counter basis, and for the (2) Tribal and Rural Allocation and (3) Higher Impact Transformative (HIT) Allocation, applications will be accepted on a competitive basis as of the date of this NOFA through December 31, 2022. High-Level Timeline

- Summer 2022 September 2022: Program Development
- September 8, 2022: Draft Guidelines Released
- September 8 September 29, 2022: Public Comment Period
- November 9, 2022: Higher Impact and Transformative Allocation NOFA released
- December 31, 2022: Final Application Deadline for All Buckets of Funding
- March 31, 2023 Submission deadline for legally binding agreements
- Spring/Summer 2023: Award Letters sent to Selected Applicants
- June 2024: Encumbrance Deadline (All Funds Must be Awarded and Encumbered)
- June 2026: Expenditure Deadline (All Funds Must be Spent by Awardees)
