## Family Transfer for a Home on Yearly Registration Renewal with HCD Certificate of Title

IMPORTANT: Return this letter with the items requested below to the address listed on page 2.

The following are instructions on how to record a family transfer of a manufactured home or mobilehome when all the following apply:

- 1. The home is titled with HCD.
- 2. The home is subject to yearly registration renewal, also known as in-lieu taxation (ILT), and bears an HCD decal number that begins with the letter "A."

In order to record a family transfer of a home meeting the above criteria, the following documents and fees must be submitted to the address listed on page 2:

- The original HCD Certificate of Title signed off by all owners printed on the title. The new owners should complete the "New Owner Information" area and sign where appropriate. If the original title has been lost, an <u>Application for Duplicate Certificate of Title</u> (form HCD RT 480.4) can be completed and submitted with a \$25 application fee.
- The original last-issued registered owner's Registration Card or, if lost, an <u>Application for Duplicate Registration Card</u> (form HCD RT 481.2) completed and submitted with a \$25 application fee.
- 3. <u>Multi-Purpose Transfer Form</u> (form HCD RT 476.6G) completed in the appropriate sections and signed by all new owners.

<sup>\*</sup> Renewal fees are due if current registration will expire within 60 days. If the registration is delinquent, renewal fees and penalties are due. If you do not know the amount due, you may visit <a href="C&S Online Services Registration Renewal">C&S Online Services Registration Renewal</a>, <a href="HCD's website">HCD's website</a>, or call (800) 952-8356 to determine the amount due. If you own the land on which the home is located, the Park Purchase Fund Fee is not due. To establish an exemption from payment of this fee, complete the "Park Purchase Fee Exemption" portion on the <a href="Multi-Purpose Transfer Form">Multi-Purpose Transfer Form</a> (form HCD RT 476.6G).
