Executive Summary

Introduction

This amendment adds Tenant-Based Rental Assistance/Rapid Rehousing (TBRA/RR) as a Goal Outcome Indicator (GOI) under the 2020-2024 Consolidated Plan (Con Plan) Goal to Increase Housing Affordability. TBRA/RR sets a GOI of 350 households assisted during the 5-year planning period. This change is made because TBRA under the HOME Investment Partnerships (HOME) Program is often used for the “Increase Housing Affordability” goal, and this was an unintended omission in the originally prepared Con Plan. Adding this GOI provides the flexibility that the program needs to be responsive to grantee program requests, changing community needs, and market conditions during the planning period.
